ORDER

Sri Mohd. Ashraf, Komaram Bheem Asifabad District-504296 has filed complaints dated 16-09-2019 which was received by this Commission on 01-10-2019 stating that the Public Information Officer-1 / O/o The District Panchayat Officer, Mancherial, Mancherial District did not implemented the Commission Order in Complaint No.2421/CIC/2018 dated 10-06-2019, Public Information Officer-2 / O/o The District Educational Officer, Jayashankar Bhupalpally District-506169 did not implemented the Commission Order in Appeal Nos.5720/SIC-BM/2018 & 5721/SIC-BM/2018 dated 03-06-2019, Public Information Officer-3 / The District Intermediate Educational Officer, Mancherial and Peddapalli, Mancherial District did not implemented the Commission Order in Appeal No. 2350/SIC-BM/2018 dated 07-08-2019 and Public Information Officer-4 / O/o The Regional Joint Director of School Education, Hanamkonda, Warangal Urban District-506001 did not implemented the Commission Order in Appeal No. 5752/SIC-BM/2018 dated 30-05-2019.

The complainant stated that he was not satisfied with the replies of the Public Information Officers, he preferred these Complaints before the Commission requesting to arrange to furnish the information sought by him U/s 18(1) of the RTI Act, 2005.

These Complaints were taken on file and notices were issued to the parties for hearing on 05-08-2021.

All the complaints filed by one Sri Mohd. Ashraf were clubbed together, and a common order is passed.

These cases are called on 05-08-2021. The Complainant is absent.

The Public Information Officer / Sri Syed Sadiq Ali, Administrative Officer, O/o The District Panchayat Officer, Mancherial, Mancherial District is present and submitted that vide reference No. 420/A1.P/2017 dated 15-11-2017, complete information was furnished to the complainant by RPAD dated 25-11-2017 and filed an affidavit to this effect.

The Public Information Officer / Sri M. Rajender, Assistant Director, O/o The District Educational Officer, Jayashankar Bhupalpally District is present and submitted that partly information was furnished the complainant and sought one week time for furnishing remaining information.

P.T.O

The Public Information Officer / Smt. R. Shailaja, District Intermediate Education Officer, O/o The District Intermediate Educational Officer, Mancherial and Peddapalli, Mancherial District is present and submitted that she brought the information to furnish the same to the complainant in presence of the Commission and also produced a copy of the letter vide Rc. No. RTI/DIEO-TSBIE/MNCL/2021 dated 05-08-2021.

The Public Information Officer / Smt. M. Vanitha, Assistant Director, O/o The Regional Joint Director of School Education, Hanamkonda, Warangal Urban District is present and submitted that the RTI applications received U/s. 6(1) and U/s. 19(1) of the RTI Act was transferred U/s. 6(3) of the RTI Act to all the Concerned District Educational Officers of Zone (V) for furnishing the information directly to the complainant, which comes under their jurisdiction and produced copies of letters before the Commission.

On perusal of material papers available on record, it is observed that the complainant filed these cases for non-compliance of the Commission orders issued in the following cases:

It is observed by the Commission that there is no further instructions given to the Public Information Officer in all the above cases to furnish any further information to the information seeker, and the cases were closed on the compliance reported therein by the Public Information Officer.

Hence these complaints filed are dismissed with a warning to the complainant not to resort to file a complaint without properly verifying the orders issued by the Commission hereafter.
