## **ORDER**

Smt. P. Baby, Bhadradi Kothagudem District-507115 has filed 2<sup>nd</sup> appeal dated 03-04-2020 which was received by this Commission on 04-04-2020 for not getting the information sought by her from the PIO / O/o The District Educational Officer, Bhadradi Kothagudem District-507101 and 1<sup>st</sup> Appellate Authority / O/o The District Educational Officer, Bhadradi Kothagudem District-507101.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 05-03-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in her application:

- mark NOV 2018.
1. Details of the subject amount sanctioned from the Govt. collector Bhadradi Kothagudem with note file copy / proceedings copy etc
  2. Details of the amount sanctioned from Govt. with regard to above programme
  3. Details of the "Sponsor" who contributed with regard to above science programme
  4. Details / amount of amount / sponsor / activities taken by ITC / BPL Bhadradi.
  5. Role of ITDA Bhadradi with regard to science fair, details of activities by ITDA Bhadradi
  6. Total rec's including vouchers (bills / Receipts which spent for above science exhibition at Bhadradi
  7. Details of Finance committee members for above science exhibition programme

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, she filed 1<sup>st</sup> appeal dated 13-08-2019 before the 1<sup>st</sup> Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by her.

The 1st Appellate Authority has not responded to the appellant.

As the appellant did not get the information from the Public Information Officer and non response from the 1<sup>st</sup> Appellate Authority even after 30 days of filing her 1<sup>st</sup> appeal, she preferred this 2<sup>nd</sup> appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by her and also to arrange to furnish the information sought by her.

The Appeal was taken on file and notices were issued to both the parties for hearing on 08-09-2021.

The case is called on 08-09-2021. The representative of the Appellant / Sri P. V. K. Upender Rao is present. The Public Information Officer / Sri P. Rama Rao, Assistant Director, O/o The District Educational Officer, Bhadradi Kothagudem District is present. The First Appellate Authority / O/o The District Educational Officer, Bhadradi Kothagudem District is absent.

The Public Information Officer brought information and the same was furnished to the appellant by hand in presence of the Commission under proper acknowledgment and filed an affidavit to this effect.

The representative of the Appellant submitted that he has received the information from the Public Information Officer.

Since information was furnished, the appeal is closed.
