ORDER

Sri B. Laxmi Narayana, Jagtial District-505460 has filed a Complaint dated 16-10-2019 which was received by this Commission on 19-10-2019 for not getting the information sought by him from the PIO / O/o The Gram Panchayat Officer, Regunta Village, Mallapur Mandal, Jagtial District-505460.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 16-10-2018 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

1. నేను, తేజ, 12-09-2018, నాడు, చేసేత, ఫింబన్ మండలం, కారకు, గ్రామ పంచాయతీ నుండి రిజిస్టర్-వారు, ముకాబాలయంకు, పంపియం చేసి అట్టి పత్రాన్ని అనుసరించి, ముకాబాలయం నుండి తీసుకువచ్చిన పత్రాల్ని నియంత్రించిన ఇరాఫీ కార్యాలయం నుండి ప్రమాణం, నా నిరుపాదన పంపించినట్లు.

The Public Information Officer has not furnished the information to the complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to both the parties for hearing on 05-03-2021.

The case was called on 05-03-2021. The Complainant was absent. The Public Information Officer / O/o The Gram Panchayat Officer, Regunta Village, Mallapur Mandal, Jagtial District was absent.

As both the parties found absent, the case was adjourned to 22-07-2021.

On 22-07-2021 the case is called. The Complainant is absent. The Public Information Officer / Sri B. Vijay Kumar, Panchayat Secretary, O/o The Gram Panchayat Officer, Regunta Village, Mallapur Mandal, Jagtial District is present.

The Public Information Officer submitted that vide letter No. A/112/2019 dated 30-10-2019, information was furnished to the complainant.

Heard the Public Information Officer and perused the material papers available on record. The Commission observed that the Public Information Officer has not produced clear copy of information provided.

Thereby, the Commission directs the Public Information Officer to furnish a copy of the letter once again which is clear and visible to the complainant within a week from the date of receipt of this order under intimation to the Commission.

With the above direction, the complaint is closed.
