ORDER

Sri T. Gopi, Khammam District has filed 2nd appeal dated 08-10-2019 which was received by this Commission on 03-02-2020 for not getting the information sought by him from the PIO / O/o The District Panchayat Officer, Khammam, Khammam District and 1st Appellate Authority / O/o The District Panchayat Officer, Khammam, Khammam District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 05-05-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

2) 2013 - 2019 వరకు అచాలన సాగునీటి సర్దుబాటు అంశంపై ఏవే కేసులు ఎంతమంది ఇచ్చినవర్కు రద్దు ఇచ్చారు? వారి అభిమానం, అభిమానం కుండలూరి కేసులు తెలుపాలి.

3) ఎక్కడ కేసులు అంశంపై చిట్టడం సర్దుబాటు ఎంతమంది నుండి సాగునీటి రక్షణ చేశారు? వారి అభిమానం కుండలూరి కేసులు తెలుపాలి.

4) ఇచ్చినవర్కు రద్దు అంశంపై ఏవే కేసులు గణపం సం॥ ఎన్నికలలో పాల్గొన్న సర్దుబాటు చేసిన వర్కులు ఏవే వర్కులు తెలుపాలి. అలాంటి వారందరి అభిమానం కుండలూరి కేసులు తెలుపాలి.

5) DPO office లోని కేసులు ఏవే అంశంపై ఏవే కేసులు తెలుపాలి.

6) DPO office లోని కేసులు ఏవే అంశంపై ఏవే కేసులు తెలుపాలి.

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 06-08-2019 before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not responded to the appellant.

As the appellant did not get the information from the Public Information Officer and non response from the 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 23-02-2021.

The case was called on 23-02-2021. The Appellant was absent. The Public Information Officer / Smt. Ch. Ushasri, Senior Assistant, O/o The District Panchayat Officer, Khammam, Khammam District was present. The First Appellate Authority / O/o The District Panchayat Officer, Khammam, Khammam District was absent.

The Public Information Officer submitted that vide letter Rc. No. P1/2000/2019 dated 18-02-2021, a reply was furnished to the appellant. He also submitted that the appellant filed 1st appeal before the First Appellate Authority and vide letter No. P1/2000/2019 dated 19-08-2019, that the appellant was invited to their office for personal hearing on 26-08-2019, but the appellant did not appear once again vide letter No. P1/2000/2019 dated 15-02-2021, the appellant was invited to their office for personal hearing on 16-02-2021. The appellant appeared for personal hearing on 16-02-2021 and verified the records.

The Commission granted one week time for furnishing the information.

The case was adjourned to 29-09-2021.

On 29-09-2021 the case is called. The Appellant is absent. The Public Information Officer / Sri Ahmad Omer Hussain, Administrative Officer, O/o The District Panchayat Officer, Khammam, Khammam District is present. The First Appellate Authority / O/o The District Panchayat Officer, Khammam, Khammam District is absent.

The Public Information Officer submitted that the appellant verified the records U/s. 2(j) of the RTI Act on 16-02-2021. He also produced a copy of acknowledgment furnished by the appellant.

The Commission directs the Public Information Officer to furnish leftover information if any to the appellant within one week from the date of receipt of this order.

With the above direction, the appeal is closed.
