ORDER

Sri Nagireddy Rajanna, Jagtial District-505460 has filed 2nd appeal dated 19-12-2019 which was received by this Commission on 23-12-2019 for not getting the information sought by him from the PIO / O/o The District Panchayat Officer, Jagtial, Jagtial District-505327 and 1st Appellate Authority / O/o The District Panchayat Officer, Jagtial, Jagtial District-505327.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 04-09-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

3. మీ కార్యాలయ నియామక/పంచాయితీ రాజ్ వ్రాసిన వ్రాతను అనుసరించి సంబంధిత లేఖపై తీసుకున్న చర్యలు తెలుపుతూ సంబంధిత లేఖ తేదీ:28-07-2019 నుండి తేదీ:03-09-2019 వరకు ఏ అధికారి వద్ద ఉంది అట్టి అధికారి పేరు హెచ్చాదా సంబంధిత అధికారి తీసుకున్న రోజువారీ చర్యలు అనుసరించిన నియమ విబంధనలు తెలుపగలరు.
4. అట్టి లేఖను సంబంధిత అధికారుల వద్దకు పంపినట్లయితే వాటికి సంబంధించి మీ కార్యాలయంలో ఉన్న రుజువులు అందజేయగలరు.
5. అట్టి లేఖపై తీసుకోవాల్సిన చర్యలను సంబంధిత అధికారులు ఆ విషయంలో సమయపాలన పాటించనందున మీ కార్యాలయ ఉద్యోగుల ప్రవర్తనా నియామక/పంచాయితీ రాజ్ అనుసరించి వారిపై సంబంధిత అధికారులు తీసుకోవాల్సిన చర్యల వివరాలు తెలుపగలరు.
పైన పేర్కొన్న సమాచారం ఇచ్చేందుకు స.పా.చట్టం-2005 ప్రకారం నా యొక్క తెలుపురంగు రేషన్ కార్డు జిరాక్సు ప్రతిని జతపర్చనైనది.

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 13-11-2019 before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not responded to the appellant.

As the appellant did not get the information from the Public Information Officer and non response from the 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 25-03-2021.

The case was called on 25-03-2021. The Appellant was absent. The Public Information Officer / O/o The District Panchayat Officer, Jagtial, Jagtial District was absent. The First Appellate Authority / O/o The District Panchayat Officer, Jagtial, Jagtial District was also absent.

As both the parties were absent, the case was adjourned to 22-07-2021.

On 22-07-2021 the case is called. The Appellant is absent. The Public Information Officer / Smt. V. Lalitha, Senior Assistant, O/o The District Panchayat Officer, Jagtial, Jagtial District is present. The First Appellate Authority / O/o The District Panchayat Officer, Jagtial, Jagtial District is absent.

The Public Information Officer submitted that she joined recently. She also submitted that vide letter No. A1/1544/2019 dated 25-09-2019, sought information was furnished to the appellant by RPAD and produced a copy of acknowledgment having received the information by the appellant and as well filed an affidavit to this effect.

As the information was furnished, the appeal is closed.
