ORDER

Sri K. Nagaraju, Warangal Rural District-506329 has filed 2nd appeal dated 05-02-2020 which was received by this Commission on 07-02-2020 for not getting the information sought by him from the PIO / O/o The Mandal Parishad Development Officer, Sangem Mandal, Warangal Rural District-506329 and 1st Appellate Authority / O/o The Mandal Parishad Development Officer, Sangem Mandal, Warangal Rural District-506329.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 16-12-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

 - 2) సంగం. మండలం ఎలక్షర్ రంగంపేట గ్రామ పంచాయతీ నుండి విడిపించిన చెక్కులు వాటికి సంబంధించిన రశీదులు. మరియు. గ.బి. బీరాక్యులు నోట్ ఫైల్ బీరాక్యులు తేది: 1 : 08 : 2019 నుండి 16 : 12 : 2019 వరకు ప్రతి పేజీని దృవీకరించే ఇవ్వగలరు.
 - 3) సంగం మండలం ఎలక్షర్ రంగంపేట గ్రామ పంచాయతీ ట్రాన్స్ యక్యు బీరాక్యులు 14 గా ఫైనాన్స్. గి.పి. ట్రాన్స్ యక్యు S.F.C ట్రాన్స్ యక్యు మొదలగు గ్రామ పంచాయతీ నిర్వహణం న మొత్తం ట్రాన్స్ యక్యు బీరాక్యులు. 01 : 04 : 2018 సం, నుండి 16 : 12 : 2019 వరకు ప్రతి పేజీని దృవీకరించే ఇవ్వగలరు.
 - 4) కె.బి.గి. (స్వచ్ఛ బాథ్ మిషన్) పథకం సంబంధించిన ఉక్విడెన్స్ బీరాక్యులు తేది: 01 : 08 : 2018 సం, నుండి 16 : 12 : 2019 వరకు పూర్తి సమాచారం దృవీకరించే ఇవ్వగలరు.
- నేను ఇవ్విన ~~వివరాలు~~ నాలుగు తింహాల తు గాను డిక్లెరు తుంహై విడి విడి గా పూర్తి సమాచారం ఇవ్వగలరు.

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 24-01-2020 before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

P.T.O

The 1st Appellate Authority has not responded to the appellant.

As the appellant did not get the information from the Public Information Officer and non response from the 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 23-02-2021.

The case was called on 23-02-2021. The Appellant was present. The Public Information Officer / O/o The Mandal Parishad Development Officer, Sangem Mandal, Warangal Rural District was absent. Sri M. Komuraiah, Mandal Panchayat Officer was present on behalf of the Public Information Officer. The First Appellate Authority / O/o The Mandal Parishad Development Officer, Sangem Mandal, Warangal Rural District was absent.

The Appellant submitted that only covering letter has been supplied by the Public Information Officer, but not the information.

The representative of the Public Information Officer submitted that vide letter No. 01/APIO/RTI/2020 dated 05-02-2020, information was furnished to the appellant. He also submitted that remaining information will be furnished within one week.

The Commission directed the Public Information Officer to furnish remaining information within one week.

The case was adjourned to 15-09-2021, with a direction to issue notice to District Panchayat Officer, Warangal Rural District to appear before the Commission on 15-09-2021 along with the above mentioned parties with complete information and RTI Registers.

On 15-09-2021 the case is called. The Appellant is absent. The Public Information Officer-1 / Smt. K. Bhavani, Superintendent, O/o The Mandal Parishad Development Officer, Sangem Mandal, Warangal Rural District is present. The Public Information Officer-2 / Smt. J. Jayalalitha, Administrative Officer, O/o The District Panchayat Officer, Warangal Rural District is present. The First Appellate Authority / Sri M. Komuraiah, Mandal Parishad Officer, O/o The Mandal Parishad Development Officer, Sangem Mandal, Warangal Rural District is present.

The Public Information Officer-1 submitted that vide letter No. 01/APIO/RTI/2020 dated 05-02-2020, sought information was furnished to the appellant by RPAD by the concerned Panchayat Secretary. Further the Public Information Officer / Mandal Praja Parishad, Sangem vide letter Rc. No. A1/RTI/2018 dated 10-03-2020 has furnished his part of information to the appellant, which was acknowledged by the appellant on 16-03-2020.

The Commission directs the Public Information Officer-1 to furnish leftover information if any to the appellant within one week from the date of receipt of this order and to report compliance to the Commission, failing which action will be initiated against the Public Information Officer under the provisions of Sec. 20 of the RTI Act.

With the above direction, the appeal is disposed off.
