ORDER

Sri B. Rajireddy, Jagtial District-505327 has filed 2nd appeal dated 08-02-2020 which was received by this Commission on 12-02-2020 for not getting the information sought by him from the PIO / O/o The District Panchayat Officer, Jagtial, Jagtial District and 1st Appellate Authority / O/o The Commissioner, Panchayat Raj and Rural Employment, Himayatnagar, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 09-09-2019 before the PIO / The District Revenue Officer, O/o The Collector and District Magistrate, Jagtial Jagtial District under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

The Public Information Officer / The District Revenue Officer, O/o The Collector and District Magistrate, Jagtial Jagtial District vide letter No. F2/1077/2019 dated 17-09-2019, has transferred the application U/s. 6(3) of the RTI Act to the Public Information Officer / O/o The District Panchayat Officer, Jagtial, Jagtial District to furnish the information directly to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 26-10-2019 before the 1st Appellate Authority / O/o The Assistant Secretary to Government, Panchayat Raj and Rural Development (Pts.II) Department, Telangana Secretariat, Hyderabad u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority / O/o The Assistant Secretary to Government, Panchayat Raj and Rural Development (Pts.II) Department, Telangana Secretariat, Hyderabad vide Memo. No. 8886/Pts.II/A2/2019-1 dated 06-12-2019, has transferred the application U/s. 6(3) of the RTI Act to the Commissioner, Panchayat Raj and Rural Employment, Himayatnagar, Hyderabad to examine the plea of the appellant and to furnish the information directly to the appellant under intimation to their office.

P.T.O

As the appellant did not get the information from the Public Information Officer and 1st Appellate Authority, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 22-07-2021.

The case was called on 22-07-2021. The Appellant was absent. The Public Information Officer / Smt. V. Lalitha, Senior Assistant, O/o The District Panchayat Officer, Jagtial, Jagtial District was present. The First Appellate Authority / O/o The Commissioner, Panchayat Raj and Rural Employment, Himayatnagar, Hyderabad was absent.

The Public Information Officer submitted that she joined recently. She also submitted that vide letter No. dated sought information was furnished to the appellant.

Heard the Public Information Officer and perused the material papers available on record the Commission observed that incomplete information was furnished to the appellant.

The Commission directed the Public Information Officer to furnish complete information to the appellant within one week and to report compliance.

The case was adjourned to 07-09-2021.

On 07-09-2021 the case is called. The Appellant is absent. The Public Information Officer / O/o The District Panchayat Officer, Jagtial, Jagtial District is absent. The First Appellate Authority / O/o The Commissioner, Panchayat Raj and Rural Employment, Himayatnagar, Hyderabad is absent.

Both the parties are absent.

A perusal of material papers goes to show that the Public Information Officer has furnished incomplete information to the complainant.

However, the Commission directs the Public Information Officer to furnish complete information to the appellant by RPAD within one week from the date of receipt of this order and to report compliance to the Commission.

With the above direction, the appeal is closed.

Issue Show Cause Notice to the then and present Public Information Officer for not furnishing the information to the complainant within the stipulated time and for not appearing before the Commission on the date of hearing. The SCN will be dealt separately.
