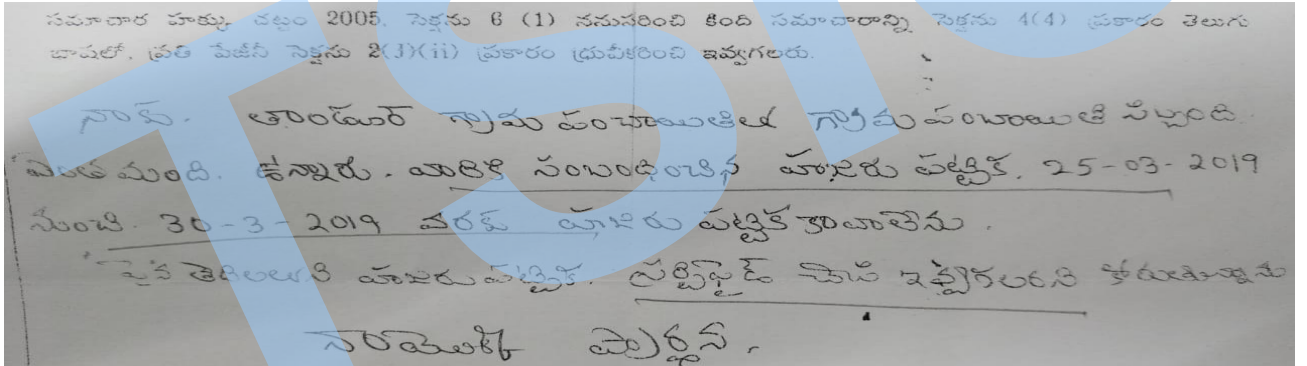

ORDER

Sri M. Charan Tej, Mancherial District-504272 has filed 2nd appeal dated 18-02-2020 which was received by this Commission on 20-02-2020 for not getting the information sought by him from the PIO / O/o The Mandal Parishad Development Officer, Tandur Mandal, Mancherial District and 1st Appellate Authority / O/o The Mandal Parishad Development Officer, Tandur Mandal, Mancherial District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 05-11-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:



The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 27-12-2019 before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not responded to the appellant.

As the appellant did not get the information from the Public Information Officer and non response from the 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 13-07-2021.

The case is called on 13-07-2021. The Appellant is present. The Public Information Officer / Sri Akhtar Mohiuddin, Mandal Panchayat Officer, O/o The Mandal Parishad Development Officer, Tandur Mandal, Mancherial District is present. The First Appellate Authority / Smt. P. Shashikala, Mandal Parishad Development Officer, O/o The Mandal Parishad Development Officer, Tandur Mandal, Mancherial District is present.

The Appellant submitted that he has not received the sought information from the Public Information Officer and filed an affidavit to this effect.

The Public Information Officer submitted that on receipt of Notice from the Telangana State Information Commission, sought information was furnished to the appellant vide letter No. M1/27/2021 dated 08-07-2021 by RPAD and produced a copy of the same before the Commission.

The Commission directs the Public Information Officer to furnish a copy of the information once again to the appellant as the information sent by RPAD might be under transit. Accordingly the Public Information Officer furnished a copy of the information to the appellant in presence of the Commission and the Commission warns the Public Information Officer to be careful in timely furnishing the information hereafter or otherwise action U/s. 20 of the RTI Act will be initiated.

With the above direction, the appeal is closed.
