## **ORDER**

Sri Narsingam Charan Kumar, Bhadradri Kothagudem District has filed a Complaint dated 08-03-2019 which was received by this Commission on 08-03-2019 for not getting the information sought by him from the PIO / O/o The Mandal Education Officer, Sujathanagar Mandal, Bhadradri Kothagudem District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 01-02-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

4. సింగభూపాలెం గ్రామం , ప్రభుత్వ ప్రాథమిక పాఠశాల నందు పని చేయుచున్న సిబ్బంది స్థానికంగా నివాసం ఉంటున్నారా ! స్థానికంగా నివాసం ఉండకుండానే ఏజెన్సీ అలవెన్సులు పొందుతున్నారా !

The Public Information Officer has not furnished the information to the complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to both the parties for hearing on 04-11-2020.

The case was called on 04-11-2020. The Complainant was absent. The Public Information Officer / Sri G. Venkat, Mandal Educational Officer (FAC), O/o The Mandal Educational Officer, Sujathanagar Mandal, Bhadradri Kothagudem District was absent.

The Public Information Officer submitted that vide letter dated 12-10-2020 sought information was furnished to the complainant.

The Commission verified the material papers available on record and found that the Public Information Officer has furnished irrelevant information to the complainant and to the Commission.

The Commission directed the Public Information Officer to furnish factual information to the complainant, within a week's time and to report compliance.

Accordingly, the case was adjourned to 23-07-2021.

On 23-07-2021 the case is called. The Complainant is absent. The Public Information Officer / Sri B. Jhumkilal, Mandal Education Officer (FAC), O/o The Mandal Education Officer, Sujathanagar Mandal, Bhadradi Kothagudem District is present.

The Public Information Officer submitted that vide letter Rc. No. 35/RTI/2020 dated 13-10-2020, sought information was furnished to the complainant. He also produced a copy of letter dated 20-02-2021 before the Commission wherein the complainant stated that he has received the information.

Since information was furnished, the complaint is closed.
