## ORDER

Sri G. Ravinder, Rajanna Siricilla District-505402 has filed 2<sup>nd</sup> appeal dated 02-03-2020 which was received by this Commission on 04-03-2020 for not getting the information sought by him from the PIO / O/o The Mandal Parishad Development Officer, Ellanthakunta Mandal, Rajanna Siricilla District and 1<sup>st</sup> Appellate Authority / O/o The Mandal Parishad Development Officer, Ellanthakunta Mandal, Rajanna Siricilla District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 11-01-2020 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

The Public Information Officer vide letter No. 4/GP/2020 dated 30-01-2020 has furnished available information to the appellant and also requested the appellant to pay an amount of Rs. 363/- towards cost of information for point nos. 1, 3 and 7.

The appellant having not satisfied with the information received from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 17-02-2020 before the 1<sup>st</sup> Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not responded to the appellant.

The appellant having not satisfied with the information received from the Public Information Officer and non response from the 1<sup>st</sup> Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 14-07-2021.

The case was called on 14-07-2021. The Appellant was absent. The Public Information Officer / O/o The Mandal Parishad Development Officer, Ellanthakunta Mandal, Rajanna Siricilla District was absent. The First Appellate Authority / O/o The Mandal Parishad Development Officer, Ellanthakunta Mandal, Rajanna Siricilla District was absent.

As both the parties were absent, the case was adjourned to 07-09-2021.

On 07-09-2021 the case is called. The Appellant is absent. The Public Information Officer / O/o The Mandal Parishad Development Officer, Ellanthakunta Mandal, Rajanna Siricilla District is absent. The First Appellate Authority / Smt. M. Vijaya, Mandal Parishad Development Officer, O/o The Mandal Parishad Development Officer, Ellanthakunta Mandal, Rajanna Siricilla District is present.

The First Appellate Authority present and submitted that the Public Information Officer has furnished the information to the appellant. She also submitted that the Public Information Officer is unable to attend in the instant case due to floods in the District. She assured the Commission that she will furnish copies of information within one day.

However, the First Appellate Authority provided information and produced copies of information before the Commission.

Since information was furnished, the appeal is closed.
