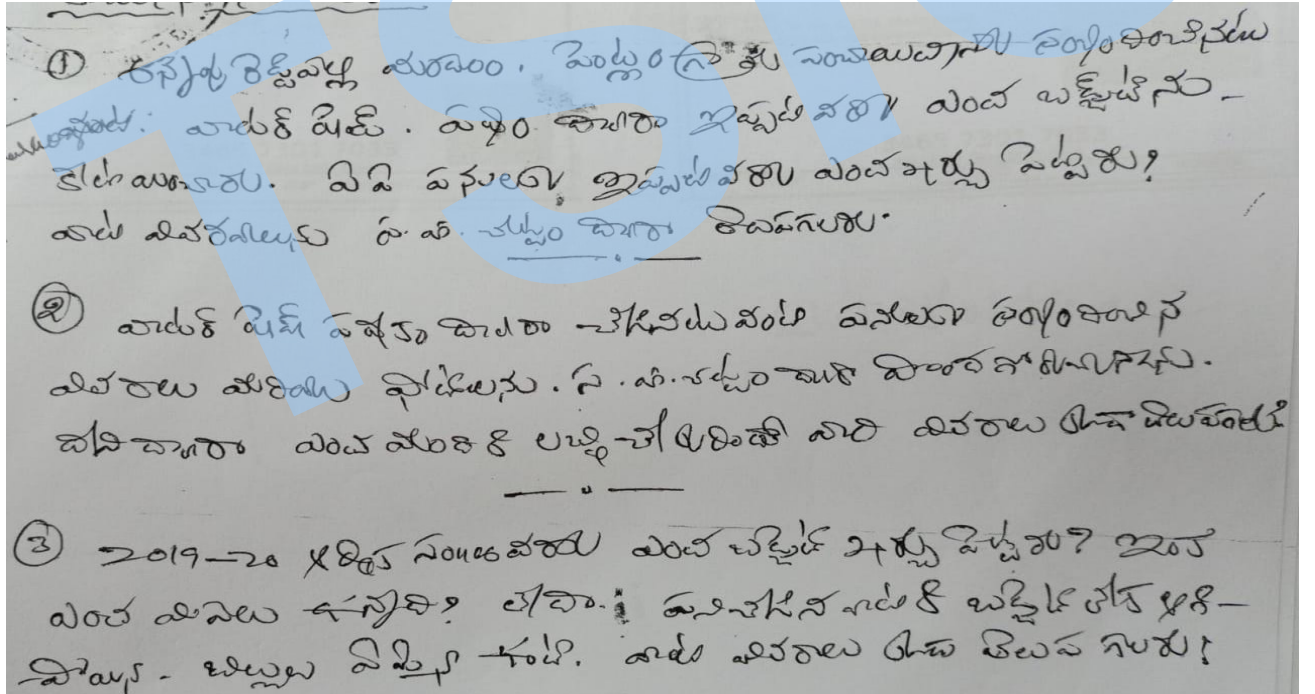

ORDER

Sri I. Kishore Kumar, Bhadradri Kothagudem District has filed 2nd appeal dated 02-03-2020 which was received by this Commission on 04-03-2020 for not getting the information sought by him from the PIO / O/o The District Rural Development Officer, Bhadradri Kothagudem District and 1st Appellate Authority / O/o The District Rural Development Officer, Bhadradri Kothagudem District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 21-11-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:



The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 20-01-2020 before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not responded to the appellant.

As the appellant did not get the information from the Public Information Officer and non response from the 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 14-07-2021.

The case is called on 14-07-2021. The Appellant is absent. The Public Information Officer / Sri R. V. Subrahmanyam, Additional District Rural Development Officer, O/o The District Rural Development Officer, Bhadradi Kothagudem District is present. The First Appellate Authority / O/o The District Rural Development Officer, Bhadradi Kothagudem District is absent.

The Public Information Officer submitted that the then Public Information Officer vide letter Rc. No. RTI/13/2019 dated 16-12-2019 has given a reply to the appellant. He also submitted that on receipt of Notice from Telangana State Information Commission, he has furnished the information to the appellant vide letter Rc. No. RTI/13/2019 dated 09-07-2021 through RPAD acknowledgment dated 10-07-2021 and filed an affidavit to this effect.

Since information was furnished, the appeal is closed.
