Having not received any information from the PIOs concerned the individual filed complaints U/s. 18(1) of the RTI Act before this Commission on dates shown against each Public Information Officer of the concerned Public Authority referred above.

As the information sought is one and the same by a single individual among different Public Authorities referred above all these cases are clubbed together and issued notices dated 28-07-2021 to all the concerned to hear the cases on 10th August, 2021.

On the above date of hearing the complainant present and putforth that in all the cases the PIOs are failed to furnish the information sought by him. Hence he filed complaints U/s. 18(1) of the RTI Act before this Commission and requested for get providing the information.

All the PIOs of the concerned Public Authorities are called separately and heard them, who failed to furnish the information in time with reference to Sec. 7(1) of the RTI Act. The PIOs expressed different versions for not furnishing the information in time, most of them putforth that they are new to the subject. The Commission felt strange to note that they have un-aware of the subject matter even after (15) years of commencement of the RTI Act, 2005.

However, it is putforth by them that they brought the information available with them to the Commission and with the permission of the Commission they have individually furnished information brought by them to the complainant in presence of the Commission.

Whatever be the motto behind in filing such large scale applications among all the Public Authorities, more particularly concerning the welfare Ashrams/Hostels functioning in the District for both Boys and Girls under the control of the Government. The PIOs expressed that they came to know after serving the Notices for Hearing by the Commission that there is exists an RTI Act and they suppose to respond to the applications filed under the Act and to supply the information held with them.

All the PIOs present are warned that if they failed to respond and failed to furnish the information within time frame of (30) days to the applicants with reference to Sec. 7(1) of the RTI Act, they are subjected to the penalties to be imposed U/s. 20(1) of the Act, and even initiation of disciplinary action against them under Section 20(2) of the RTI Act.

Issue Show Cause Notices to the following PIOs who failed to appear before the Commission for hearing to-day as well for not responding to the application filed U/s. 6(1) of the Act, duly ascertaining the details of the PIOs.

The Collector and District Magistrate, Bhadradi Kothagudem District who is a Nodal Officer in implementing the RTI Act in the District is suggested to take all necessary steps to impart Training on RTI Act to all the PIOs/FAAs of the concerned Public Authorities in the District through Dr.MCRHRD Institute by conducting seminars on RTI Act in a phased manner in the District. The Commission suggested to review this Act once in three months during their Revenue Officers conferences.

With the above directions, all the complaints, wherein information has been furnished are closed.
