## **ORDER**

Sri G. Srinivas, Mahabubabad District-506101 has filed 2<sup>nd</sup> appeal dated NIL which was received by this Commission on 06-06-2020 for not getting the information sought by him from the PIO / O/o The Tahsildar, Penuballi Mandal, Khammam District and 1<sup>st</sup> Appellate Authority / O/o The Revenue Divisional Officer, Kalluru Division, Khammam District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 23-09-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

- 1) 2018లో జరిగిన శాసనసభ ఎన్నికల నిర్వహణ ఖర్చుల నిమిత్తం మీ కార్యాలయానికి వచ్చిన నిధులు ఎన్ని? తేదీల వారీగా ఏ కార్యాలయం నుండి వచ్చినవి తేదీల వారీగా ఇవ్వగలరు.
- 2) 2018లో జరిగిన శాసనసభ ఎన్నికల నిర్వహణ ఖర్చుల కొరకు మీ కార్యాలయానికి వచ్చిన నిధులు, ఖర్చు చేసిన వివరములు, దేనికి ఎంత ఖర్చు చేసింది, బిల్లులతో సహా వివరాలు ధృవీకరించి ఇవ్వగలరు.
- 3) 2018ల జరిగిన శాసనసభ ఎన్నికల నిర్వహణకు మీ కార్యాలయం నుండి వాడిన వాహనాలు, వాహనాల నిర్వహణ ఖర్చులు, ఎన్నికలరోజు పోలింగ్ కేంద్రాలలో అయిన ప్రతిదీ వివరాలు ఇవ్వగలరు.

The Public Information Officer has given a reply to the appellant vide letter Rc. No. RTI/77/2019 dated 27-09-2019.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 31-10-2019 before the 1<sup>st</sup> Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1<sup>st</sup> Appellate Authority has heard the 1<sup>st</sup> appeal and issued order vide RTI Appeal No. C/2395/2019 dated 21-12-2019, with a direction to the Public Information Officer / O/o The Tahsildar, Penuballi Mandal, Khammam District to furnish the information to the appellant within (10) days under intimation to their office.

The Public Information Officer has furnished the information to the appellant vide letter Rc. No. C/RTI/77/2019 dated 14-01-2020.

The appellant having not satisfied with the information received from the Public Information Officer and 1<sup>st</sup> Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 24-08-2021.

The case is called on 24-08-2021. The Appellant is absent. The Public Information Officer / O/o The Tahsildar, Penuballi Mandal, Khammam District is absent. The Assistant Public Information Officer / Sri J. Laxmaiah, Senior Assistant is present on behalf of the Public Information Officer. The First Appellate Authority / O/o The Revenue Divisional Officer, Kalluru Division, Khammam District is absent.

The Assistant Public Information Officer submitted that vide letter Rc. No. C/RTI/77/2019 dated 27-09-2019, a reply was furnished to the appellant stating that the sought information is available with Sathupally Constituency. He also submitted that on 13-10-2019 the appellant filed another 6(1) application before their office and vide letter Rc. No. C/RTI/77/2019 dated 24-01-2020, information was furnished to the appellant.

Since information was furnished, the appeal is closed.
