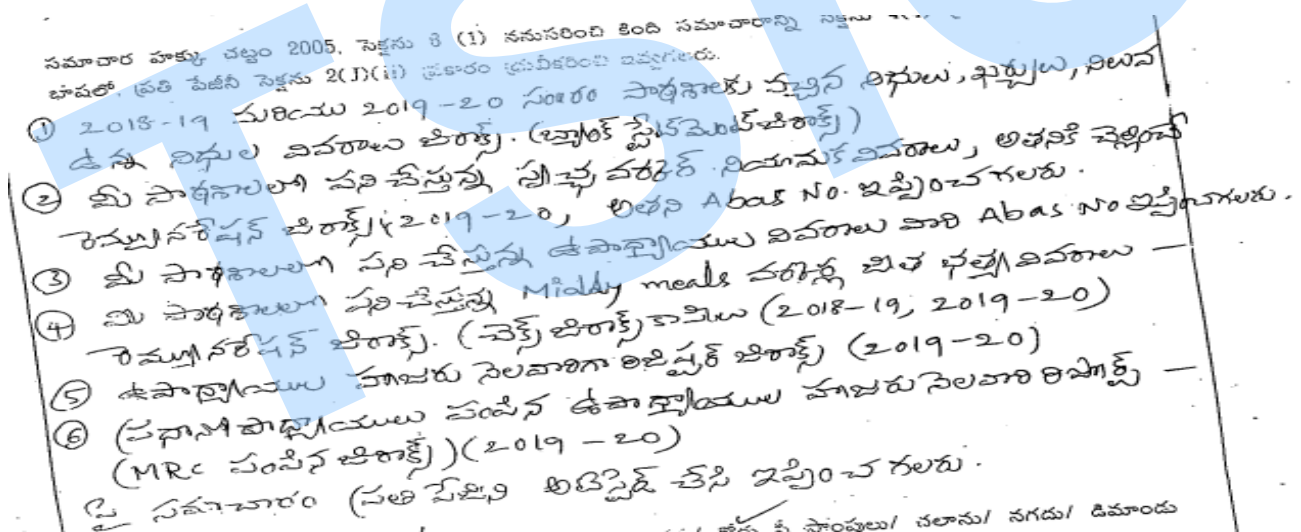

## **ORDER**

Sri K. Venkateswarlu, Warangal Rural District-506164 has filed 2<sup>nd</sup> appeal dated 03-06-2020 which was received by this Commission on 08-06-2020 for not getting the information sought by him from the PIO / O/o The Head Master, Government High School, Parkal Mandal, Warangal Rural District-506164 and 1<sup>st</sup> Appellate Authority / O/o The Head Master, Government High School, Parkal Mandal, Warangal Rural District-506164.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 07-03-2020 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:



The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 11-05-2020 before the 1<sup>st</sup> Appellate Authority / O/o The District Educational Officer, Warangal Rural District u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1<sup>st</sup> Appellate Authority / O/o The District Educational Officer, Warangal Rural District vide proceedings Rc. No. 889/B4/2020 dated 22-05-2020, has transferred the application U/s. 6(3) of the RTI Act to the Public Information Officer / O/o The Head Master, Government High School, Parkal Mandal, Warangal Rural District to furnish the information directly to the appellant under intimation to their office.

As the appellant did not get the information from the Public Information Officer and 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 08-09-2021.

The case is called on 08-09-2021. The Appellant is present. The Public Information Officer / Sri V. Bhaskar, Head Master, O/o The Head Master, Government High School, Parkal Mandal, Warangal Rural District is present. The First Appellate Authority / O/o The Head Master, Government High School, Parkal Mandal, Warangal Rural District is absent.

The Public Information Officer brought information and the same was furnished to the appellant in presence of the Commission under proper acknowledgment.

The Appellant received the information furnished by the Public Information Officer.

The Commission directed the Public Information Officer to furnish leftover information if any to the appellant within one week from the date of receipt of this order and to report compliance to the Commission, failing which action will be initiated against the Public Information Officer under the provisions of Sec. 20 of the RTI Act.

With the above direction, the appeal is closed.
