ORDER

Sri Bethi Rajireddy, Jagtial District-505327 has filed a Complaint dated 01-06-2020 which was received by this Commission on 09-06-2020 for not getting the information sought by him from the PIO / O/o The Municipal Commissioner, Jagtial Municipality, Jagtial District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 08-01-2020 before the PIO / Assistant Secretary, Telangana State Election Commission, A.C. Guards, Hyderabad under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

The Public Information Officer / Assistant Secretary, Telangana State Election Commission, A.C. Guards, Hyderabad vide letter No. 91/TSEC-RTI/2019 dated 19-01-2020, has transferred the application U/s. 6(3) of the RTI Act to the Public Information Officer / O/o The Municipal Commissioner, Jagtial Municipality, Jagtial District for taking necessary action at their office.

The Complainant having not received the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and notices were issued to both the parties for hearing on 07-09-2021.

The case is called on 07-09-2021. The Complainant is absent. The Public Information Officer / Smt. G. Tejaswini, Town Planning Supervisor, O/o The Municipal Commissioner, Jagtial Municipality, Jagtial District is present.

The Public Information Officer submitted that sought information was furnished to the complainant in two spells i.e., vide letter No. M.C.J/Elections/383/2019 dated 14-12-2019 and vide letter No. 219/RTI/4817-20/2020 dated 23-08-2021, sought information was furnished to the appellant by RPAD and filed an affidavit to this effect.

Heard the Public Information Officer and perused the material papers available on record. The Commission observed that the Public Information Officer did not produce copy of postal acknowledgment before the Commission to show that information was furnished to the appellant.

However, the Commission directs the Public Information Officer to furnish the sought information once again to the appellant by RPAD within two days from the date of receipt of this order and to report compliance to the Commission.
