## **ORDER**

Sri Ch. Mahesh, Rajanna Siricilla District-505302 has filed 2<sup>nd</sup> appeal dated 17-07-2020 which was received by this Commission on 23-07-2020 for not getting the information sought by him from the PIO / O/o The Revenue Divisional Officer and Special Deputy Collector, Land Acquisition Unit-VII, Rajanna Siricilla District-505301 and 1<sup>st</sup> Appellate Authority / O/o The Special Collector (Land Acquisition) and Additional Collector, Rajanna Siricilla District-505301.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 14-02-2020 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

Please provide me below information on the above project.

1. How much Land identified/notified for acquisition in survey numbers 119, 125, 126 & 142.
2. How much Land Deferred/due for award/payment in Sy. numbers 119, 125, 126 & 142.
3. Provide me total award copies that contains proposed land from survey numbers 119, 125, 126 & 142 to make payments to land Owners/Beneficiaries.
4. Provide me a copy of enjoyment survey report (Prepared/Wrote by Surveyor) that showing survey numbers 119, 125, 126 & 142.
5. Provide me a copy of recent enjoyment survey report (signed by DRO) that showing survey numbers 119, 125, 126 & 142.

#### 4. Application and information fee details

Here I declare that I am belonging to BPL category person. So, provide me requested information as per section 7(5) of the RTI Act 2005 for free of cost. Also attached my white ration card and Food security card with this application.

#### 5. Below items are for your kind information and consideration

- a. As per section 6(3) of the RTI Act 2005, In case, the requested information is held by another public authority, I request the PIO to transfer the application or part of it within FIVE days and immediately inform me about such transfer.
- b. As per section 7(5) of the RTI Act 2005, Provided that the fee prescribed under sub-section (1) of section 6 and sub-sections (1) and (5) of section 7 shall be reasonable and no such fee shall be charged from the persons who are of below poverty line as may be determined by the appropriate Government.
- c. As per section 7(8) (iii) and 7(3) (ii) of the RTI Act 2005, I request the PIO to inform me of the particulars of First Appellate Authority.

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 16-03-2020 before the 1<sup>st</sup> Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has furnished the information to the appellant vide letter No. H/808/2020 dated 18-06-2020.

As the appellant did not get the information from the Public Information Officer, he preferred this 2<sup>nd</sup> appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 21-09-2021.

The case is called on 21-09-2021. The Appellant is present. The Public Information Officer / O/o The Revenue Divisional Officer and Special Deputy Collector, Land Acquisition Unit-VII, Rajanna Siricilla District is absent. Sri D. Sreenivas, Naib Tahsildar is present on behalf of the Public Information Officer. The First Appellate Authority / O/o The Special Collector (Land Acquisition) and Additional Collector, Rajanna Siricilla District is absent.

The Appellant submitted that he is seeking total award copies that contained proposed land form survey Nos. 119, 125, 126 and 142 to make payments to land owners/beneficiaries, which was not furnished by the Public Information Officer.

The representative of the Public Information Officer submitted that vide letter No. A/06/2020 dated 18-09-2021, available and held information was furnished to the appellant.

As the appellant claims that he did not receive the complete information from the Public Information Officer.

The Commission directs the Public Information Officer to furnish leftover information to the appellant within one week from the date of receipt of this order and to report compliance to the Commission, failing which action will be initiated against the Public Information Officer under the provisions of Sec. 20 of the RTI Act.

With the above direction, the appeal is closed.
