ORDER

Sri K. Veera Goud, Sangareddy District-502273 has filed Complaints dated 27-07-2020 which was received by this Commission on 28-07-2020 for not getting the information sought by him from the PIO / O/o The Commissioner, Panchayat Raj and Rural Employment, Himayatnagar, Hyderabad.

The brief facts of the cases as per the Complaints and other records received along with it are that the Complainant herein filed an application dated 29-02-2020 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his applications annexed.

Case No. : 6017/SIC-GSN/2020

I, Kalali Veera Goud, MPTC Korpole, Pulkal Mandal, want you to provide me the following information.

- 1. Service register of Sri V.Venkateshwarlu, who presently working as DPO at Sangareddy District**

Case No. : 6022/SIC-GSN/2020

I, Kalali Veera Goud, MPTC Korpole, Pulkal Mandal, want you to provide me the following information.

I, Certified copies of initial appointment orders issued in respect of Sri. V.Venkateshwarlu, who presently working as DPO at Sangareddy

The Public Information Officer has not furnished the information to the complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his applications, he preferred these Complaints before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

These Complaints were taken on file and notices were issued to both the parties for hearing on 27-08-2021.

These cases are called on 27-08-2021. The Complainant is absent. The Public Information Officer / Smt. B. Maha lakshmi, Assistant Commissioner, O/o The Commissioner, Panchayat Raj and Rural Employment, Himayatnagar, Hyderabad is present.

The Public Information Officer submitted that vide letter No. 8078-1/CPR&RE/B1/2019 dated 23-03-2020, the RTI application received U/s. 6(1) was transferred U/s. 6(3) of the RTI Act to the Public Information Officer / O/o The District Panchayat Officer, Sangareddy District for supplying the information sought by the complainant. She also submitted that vide Memo. No. 8078/CPR&RE/B1/RTI/2019 dated 26-08-2021 the Public Information Officer / O/o The District Panchayat Officer, Sangareddy District is directed to appear before the Hon'ble Information Commission in person on date of hearing i.e., 27-08-2021 as deemed Public Information Officer.

Sri A. Druga Prasad, Administrative Officer, O/o The District Panchayat Officer, Sangareddy District is present and submitted that vide letter No. 63/2021/A1-Pts-CPR-1 dated 18-08-2021 & vide letter No.63/2021/A1-Pts-CPR-6 dated 18-08-2021, replies were furnished to the complainant stating that personal details of the employees cannot be produced as per rules of the RTI Act, 2005.

Heard the Public Information Officers and perused the material papers available on record. The Commission observed that the complainant is seeking Service Register of Sri V. Venkateshwarlu, working as District Panchayat Officer at Sangareddy District. It is also seen that the information sought also interlinked with the case No. 6022/SIC-GSN/2020, the case is clubbed together.

However, the Commission directs the Public Information Officer to furnish the service details of District Panchayat Officer from his Service Book, duly collecting the details from the Service Book where it is being maintained to the complainant by RPAD within one week from the date of receipt of this order and to report compliance to the Commission, failing which action will be initiated against the Public Information Officer under the provisions of Sec. 20 of the RTI Act.

With the above direction, these complaints are closed.
