It is observed that the complainant is seeking personal information of the public servants in all most all cases, having no public interest the same was rejected U/s. 8(1)(j) of the RTI Act. The Commission opined that, the complainant is wasting precious time of the public authorities as well of the Commission by seeking personal information of the Government servants having no larger public interest which need be avoided.

The Commission further observed that the appropriate replies were given by the Public Information Officers by furnishing available and held information to the complainant.

It is further observed by the Commission that the PIOs concerned at Sl. Nos. 1, 2, 5, 7 and 8 are failed to respond to the RTI applications filed, within (30) days time with reference to Sec. 7(1) of the RTI Act, 2005. They are warned to desist from this practice hereafter, failing which they have to face action U/s. 20 of the RTI Act

With the above direction, these complaints filed are disposed off.
