ORDER

Sri G. Kalyan Chakravarthy, Ranga Reddy District-500070 has filed 2nd appeal dated 17-08-2020 which was received by this Commission on 18-08-2020 for not getting the information sought by him from the PIO / O/o The Principal, Government Polytechnic, Masab Tank, Hyderabad-500028 and 1st Appellate Authority / O/o The Principal, Government Polytechnic, Masab Tank, Hyderabad-500028.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 01-06-2020 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

1. Please furnish the certified/attested copies of month wise Biometric Attendance containing In time & Out time of all Lecturers in the Civil Engineering section of your polytechnic from the month of December 2018 to 15th March 2020.
2. Please furnish the certified photocopy of the General section staff attendance register of your college for the month of July 2015.

The Public Information Officer vide letter No. GPT/RTI/2020 dated 30-06-2020, has stated the appellant to pay an amount of Rs. 2000/- towards cost of information.

The appellant having not received the information from the Public Information Officer, he filed 1st appeal dated 06-07-2020 before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not responded to the appellant.

The appellant having not received the information from the Public Information Officer and non response from the 1st Appellate Authority, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 13-08-2021.

The case is called on 13-08-2021. The Appellant is absent. The Public Information Officer / Sri J. Nadamuni Gupta, Head of Section, O/o The Principal, Government Polytechnic, Masab Tank, Hyderabad is present. The First Appellate Authority / O/o The Principal, Government Polytechnic, Masab Tank, Hyderabad is absent.
