## **ORDER**

Sri L. Rajaiah, Mancherial District has filed 2<sup>nd</sup> appeal dated 17-08-2020 which was received by this Commission on 20-08-2020 for not getting the information sought by him from the PIO / O/o The Gram Panchayat Secretary, Rajapur Village, Ramagiri Mandal, Peddapalli District-505212 and 1<sup>st</sup> Appellate Authority / O/o The Mandal Parishad Development Officer, Ramagiri Mandal, Peddapalli District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 19-09-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

- 1) రాజీవుర్ గ్రామ పంచాయతలలో ప్రంక్ష నిర్మాణము కుటు తరగూస్తూ ఎవరికి చెనుకూలు. ఎన్నికాచీలలో ఉయమల ప్రస్తావి. దానికీ అవలూతిన నిబంధనల వివరాల ప్రవ్వగలరు.
- 2) కలయలో ప్రంక్ష నిర్మాణము చెనుకూలూతో గ్రామ పంజ్చుల ఎప్పకూ జేకీ ప్రంక్ష నిర్మాణ ప్రస్తావి వివరాల ప్రవ్వగలరు.
- 3) రాజీవుర్ గ్రామయలో ప్రంక్ష నిర్మాణ చెప్పట్టదానికీ ఉయమలూల శ్రీశ్రయో? తివా శ్రాటి ఉయమలూల కుటు ప్రజ్చున్ ఠాటి ల కవల ప్రవ్వగలరు తిరవోటి ఎంకూు తిక్కి శ్రీశ్ర చయూయ ప్రవ్వగలరు.

The Public Information Officer has given a reply to the appellant vide letter dated 18-10-2019.

The appellant having not satisfied with the reply received from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 01-11-2019 before the 1<sup>st</sup> Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not responded to the appellant.

The appellant having not satisfied with the reply received from the Public Information Officer and non response from the 1<sup>st</sup> Appellate Authority, he preferred this 2<sup>nd</sup> appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 23-09-2021.

The case is called on 23-09-2021. The Appellant is present. The Public Information Officer / Smt. K. Vanitha, Junior Panchayat Secretary, O/o The Gram Panchayat Secretary, Rajapur Village, Ramagiri Mandal, Peddapalli District is present. The First Appellate Authority / O/o The Mandal Parishad Development Officer, Ramagiri Mandal, Peddapalli District is absent. Sri K. Bhasker, Mandal Panchayat Officer is present on behalf of the Public Information Officer.

The Public Information Officer brought information and the same was furnished to the appellant in presence of the Commission vide letter No. RTI/13/2019 dated 22-09-2021.

The Appellant submitted that false information has been provided by the Public Information Officer.

Heard both the parties and perused the material papers available on record. It is observed from the record that for point Nos. 2 and 3 are in the form of questions and the appellant tried to elicit answers by putting questions.

The Commission directs the Public Information Officer to furnish complete information within one week from the date of receipt of this order and to report compliance to the Commission, failing which action will be initiated against the Public Information Officer under the provisions of Sec. 20 of the RTI Act.

With the above direction, the appeal is closed.
