ORDER

Sri Ch. Satyanarayana Sarma, Hyderabad-500018 has filed 2nd appeal dated 28-08-2020 which was received by this Commission on 31-08-2020 for not getting the information sought by him from the PIO / O/o The Gram Panchayat Secretary, Aushapur Village, Ghatkesar Mandal, Medchal-Malkajgiri District and 1st Appellate Authority / O/o The Tahsildar, Ghatkesar Mandal, Medchal-Malkajgiri District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 19-08-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

3. PARTICULARS OF INFORMATION REQUIRED

(i) Subject matter of information : I have purchased plot No. 40, in Sy. No. 260 of Aushapur (V) on 05.07.1983. I am attaching xerox copy of my sale deed with this application form. The seller is P. Subbaiah Naidu, who had applied & got the layout duly sanctioned vide gram panchayat proceeding No 77 dt. 21.02.1983

(ii) Period to which the information relates : 01.01.1983 - 31.12.1983
I request you to please issue me a copy of the gram panchayat approved layout copy. Proceeding No 77 dt. 21.02.1983

(iii) Description of information required : (Details may be attached on additional A4 size paper if required)
Gram Panchayat layout sanctioned copy vide panchayat Proceeding No 77, dated 21.02.1983

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 23-10-2019 before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not responded to the appellant.

As the appellant did not get the information from the Public Information Officer and non response from the 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 06-08-2021.

The case is called on 06-08-2021. The Appellant is absent. The Public Information Officer / Smt. R. Umadevi, Panchayat Secretary, O/o The Gram Panchayat Secretary, Aushapur Village, Ghatkesar Mandal, Medchal-Malkajgiri District is present. The First Appellate Authority / O/o The Tahsildar, Ghatkesar Mandal, Medchal-Malkajgiri District is absent.

The Public Information Officer submitted that vide letter No. GPA.46/2021 dated 03-08-2021, sought information was furnished to the appellant by RPAD.

However, the Commission warns the Public Information Officer to be careful in timely furnishing the information hereafter or otherwise action will be initiated against the concerned Public Information Officer U/s. 20 of the RTI Act.

Since information was furnished, the appeal is closed.
