ORDER

Sri B. Raju, Rajanna Siricilla District-505402 has filed 2nd appeal dated 02-09-2020 which was received by this Commission on 05-09-2020 for not getting the information sought by him from the PIO / O/o The Mandal Parishad Development Officer, Ellanthakunta Mandal, Rajanna Siricilla District and 1st Appellate Authority / O/o The Mandal Parishad Development Officer, Ellanthakunta Mandal, Rajanna Siricilla District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 19-05-2020 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

The Public Information Officer vide letter No. A5/76/2020 dated 17-06-2020, has requested the appellant to pay an amount of Rs. 1,292/- towards cost of the information

The appellant having not received the information from the Public Information Officer, he filed 1st appeal dated 30-07-2020 before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has responded vide letter No. A1/76/2020 dated 13-08-2020, calling for explanation of the Public Information Officer as to why sought information was not furnished to the appellant with the stipulated time and the same was informed to the appellant.

The appellant having not received the information from the Public Information Officer and 1st Appellate Authority, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and notices were issued to both the parties for hearing on 23-09-2021.

The case is called on 23-09-2021. The Appellant is present. The Public Information Officer / O/o The Mandal Parishad Development Officer, Ellanthakunta Mandal, Rajanna Siricilla District is absent. The First Appellate Authority / O/o The Mandal Parishad Development Officer, Ellanthakunta Mandal, Rajanna Siricilla District is absent.

The Appellant submitted that he has paid Rs. 1292/- towards cost of the information consisting of total 646 pages. He also submitted that the Public Information Officer has furnished 569 pages only. He further submitted that the information furnished by the Public Information Officer is complete different for what he is seeking in his plea filed U/s. 6(1) of the RTI Act.

The Commission directs the Public Information Officer to furnish correct and complete information to the appellant in consultation of the appellant within one week from the date of receipt of this order and to report compliance to the Commission, failing which action will be initiated against the Public Information Officer under the provisions of Sec. 20 of the RTI Act.

With the above direction, the appeal is closed.
