ORDER

Sri V. Satyanarayana, Khammam District-507208 has filed 2nd appeal dated 06-09-2020 which was received by this Commission on 08-10-2020 for not getting the information sought by him from the PIO / O/o The Tahsildar, Chinthakani Mandal, Khammam District and 1st Appellate Authority / O/o The Revenue Divisional Officer, Khammam Division, Khammam District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 07-03-2020 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

- 1) ఆంధ్రప్రదేశ్ మండలం, రివెన్యూ డివిజన్ కింద ఉన్న పేరెంట్ నెంబర్ 297/A1 పేరాలో నవంబరు 1995 నుండి 2019 వరకు వరకు కేసులను "Attached" చేసి, కేసులను - తరచుగా పొందడం 269 యొక్క 1B రిజిస్ట్రేషన్ నెంబర్ "Attached" చేసిన కేసులను కేసులను పంపించాలి.
- 2) పైన పేర్కొన్న కేసులకు సంబంధించిన డాక్యుమెంట్ లు పంపించాలి, వారి సంబంధించిన R.O.R. procedure 6/13B or act యంతర్వేదిక, procedure ను అందించాలి, కేసులను "Attached" చేసి, కేసులను (సం|| 1995 నుండి, 2019 సం|| 2016 వరకు అందజేయాలి).
- 3) నేను అయితే నాకు పేరా నెంబర్ లో ఉన్న సమాచారం నుండి నా కేసులను పంపించాలి, వారి సంబంధించిన కేసులను, వారి "Attached" చేసి, కేసులను -
----- నామ సంవత్సరం ప్రకారం ప్రతి స్వయం ప్రతికరణ కేసి పంపగలరు.

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 29-07-2020 before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has issued notice to the appellant and the Public Information Officer / O/o The Tahsildar, Chinthakani Mandal, Khammam District vide Notice No. B2/3060/2020, dated 28-08-2020 to appear before their office for hearing on 11-09-2020 at 03:00 PM along with connected records. Further action thereon is not known

As the appellant did not get the information from the Public Information Officer and 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The case is called on 24-09-2021. The Appellant is absent. The Public Information Officer / O/o The Tahsildar, Chinthakani Mandal, Khammam District is absent. The Assistant Public Information Officer / Ms. D. V. Jasmin, Senior Assistant is present on behalf of the Public Information Officer. The First Appellate Authority / O/o The Revenue Divisional Officer, Khammam Division, Khammam District is absent.

The Assistant Public Information Officer submitted that vide letter Rc. No. RTI/A/37/2020 dated 06-10-2020, sought information was furnished to the representative of the appellant and produced copies of the same before the Commission.

Since information was furnished, the appeal is closed.
