ORDER

Sri Mir Zahid Ali, Hyderabad has filed a Complaint dated Nil which was received by this Commission on 07-12-2020 for not getting the information sought by him from the PIO / The District Revenue Officer O/o the District Collector, Medak District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 22-11-2019 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

Sub: Merciful request to provide C.C. copy under R.T.I. Act 2005 - At the time of submission before you on 20-08-2010 attached all property documents (in Urdu & English Script) - Reg.

Ref: Agriculture land in Survey No.642, 174, 307, 635 and so on, situated at Waddiaram village, Chegunta Mandal, Medak District - Mir Iftequar Ali, Mir Zamin Ali, Mir Naser Ali. enclosed the document before you as Muntakhab copy.

I, Mir Zahid Ali S/o. Mir Khurshid Ali, r/o. 17-3-433/134/1 Yakutpura, Ganga Nagar, Hyderabad-23, that on 20-08-2010 I submitted before the Collector, Sangareddy HQRS, Medak District for mutation of property enclosed all Muntakhab etc.

Now I require the said Muntakhab copy i.e. C.C. copy of the submitted application and also enclosed copy (certified copies) under RTI Act.

I am herewith enclosed Rs.20/- court fee stamp for your reference.

The Public Information Officer has not furnished the information to the Complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and case is posted for hearing on 17-03-2021.

"The case is called on 17-03-2021. The Complainant is present. The Public Information Officer is absent. Sri T. Naresh, Senior Assistant is present on behalf of the Public Information Officer.

The Complainant submitted that he has not received the sought information from the Public Information Officer.

The representative of the Public Information Officer submitted that the RTI application was transferred U/s.6(3) of the RTI Act to the Public Information Officer /O/o. The Tahsildar, Chegunta Mandal, Medak District for furnishing the sought information to the complainant.

The Commission directed the Public Information Officer/ The Tahsildar, Chegunta Mandal, Medak District to furnish the sethwar and mutation copies to the complainant, within two weeks from the date of receipt of this order and to report compliance to the Commission.”

The case was adjourned for next hearing.

The case is called on 02-09-2021. The Complainant is present. The Public Information Officer/Sri S. Madhusudhan, Naib Tahsildar is present.

The Complainant submitted that he has not received the sought information from the Public Information Officer.

The Public Information Officer submitted that available information was furnished to the complainant. He also submitted that Muntakhab copy was not available in their office.

The Commission directed the Public Information Officer to furnish the sought information to the complainant, within two weeks from the date of receipt of this order and to report compliance to the Commission.

With the above direction, the complaint is closed.
