ORDER

Sri Shaik Shabbier, Nizamabad has filed a complaint dated 04-09-2019 which was received by this Commission on 05-09-2019 stating that the Public Information Officer-1 / O/o the Executive Engineer, Construction Division, Kaleshwaram Project, Irrigation and CAD Department, Nizamabad District Public Information Officer-2 / O/o the Executive Engineer, Project Division, Irrigation and CAD Department, Bodhan, Nizamabad District did not implemented the Commission Order in Appeal/Complaint No 15399/CIC/2018 dated 21-06-2019.

The complainant stated that he was not satisfied with the reply of the Public Information Officer, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him U/s 18(1) of the RTI Act, 2005.

The Complaint was taken on file and case was posted for hearing on 28-01-2021.

“The case is called on 28-01-2021. The Complainant is present. The Public Information Officer-1/ Sri B. Rajeshwar, Divisional Accounts Officer is present. The Public Information Officer-2/ KNVJP Narayana, Divisional Accounts Officer is present.

The case was adjourned to 09-06-2021 for proper response.

“On overview spread of COVID-19, the case is heard over phone on 09-06-2021. Both the parties are contacted on telephone. The Complainant and the Public Information Officer are heard.

The Complainant submitted that he has not received the sought information from the Public Information Officer.

The Public Information Officer submitted that he has joined recently and requested the Commission to grant ten days time for furnishing the information.”

The case was adjourned to 03-08-2021.

The case is called on 03-08-2021. The Complainant is present. The Public Information Officer-1/Sri A.Balaram, Deputy Executive Engineer is present. The Public Information Officer-2/Sri Venkataramana, Deputy Executive Engineer is present.

The Complainant submitted that he has received the part information from the Public Information Officer. He also submitted that lands are encroached and no officials are responding.

The Public Information Officer submitted that the complainant is seeking the information regarding center width of Nizamsagar canal and also right and left side canal widths at Baban shab phadi bridge, Nizamabad. He also submitted that vide letter No.EE/PD/BDN/RTI-2005/PIO/458 dated 29-08-2019, a reply was given to the complainant. He further submitted that they have marked the canal adjacent area and letter was addressed to Assistant Director, Survey and Land Records, Nizamabad.
