The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 18-12-2020 before the 1<sup>st</sup> Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not furnished the information to the Appellant.

As the appellant did not get the information from the Public Information Officer / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and the case is posted for hearing on 02-09-2021.

The case is called on 02-09-2021. The Appellant is present. The Public Information Officer is absent. Sri P. Vijay, Naib Tahsildar is present on behalf of the Public Information Officer. The First Appellate Authority is absent.

The Appellant submitted that he has not received the sought information from the Public Information Officer.

The representative of the Public Information Officer submitted that the appellant is seeking information regarding a way existing in survey numbers 78, 82 and 88 as per village naksha of Mahadevpoor village of Balmoor Mandal. He also submitted that the way is encroached by Sri Sudhakar Reddy, Advocate due to which villagers who are passing from Mahadevpoor to Gattuthumen are facing much difficult. He further submitted that the Tahsildar, Balmoor Mandal vide Endorsement No. B/325/2020 dated 29-12-2020, informed the appellant that survey will be conducted.

The Commission directed the Public Information Officer to conduct survey and solve the issue of the appellant, within two weeks from the date of receipt of this order and to report compliance to the Commission.

With the above direction, the appeal is closed.
