ORDER

Sri Madasu Srinu, Suryapet District has filed a complaint dated 28-12-2020 which was received by this Commission on 28-12-2020 stating that the Public Information Officer / The Extension Officer,(PR & RD), O/o the MPDO, MPP, Kodad Mandal, Suryapet District did not implemented the Commission Order in **7662/SIC-KSR/2019** dated **07-10-2020**.

The complainant stated that he was not satisfied with the reply of the Public Information Officer, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him U/s 18(1) of the RTI Act, 2005.

The Complaint was taken on file and case was posted for hearing on 03-08-2021.

“The case is called on 03-08-2021. The Complainant is present. The Public Information Officer / Sri A. Pandu Ranganna, Mandal Panchayat Officer is present.

The Complainant submitted that he has not received the sought information from the Public Information Officer.

The Public Information Officer submitted that he has furnished the available information to the complainant. He requested the Commission to grant two weeks time for furnishing the information.

Heard both the parties and perused the material papers available on record. The Commission directed the Public Information Officer to furnish the 4(1)(b) information to the complainant, within two weeks.”

The case was adjourned to 21-09-2021.

The case is called on 21-09-2021. The Complainant is present. The Public Information Officer/Sri A.Pandu Ranganna, Mandal Panchayat Officer is present.

The Complainant submitted that he has not received the sought information from the Public Information Officer.

The Public Information Officer submitted that sought information was furnished to the complainant on 18-09-2021.

Heard both the parties and perused the material papers available on record. The Commission observed that there is no proof of having sent the above information and directed the Public Information Officer to furnish the sought information to the complainant, through Registered post with acknowledgment due, within two weeks from the date of receipt of this order and to report compliance to the Commission.

With the above direction, the complaint is closed.
