ORDER

Sri Prakash, R.R District has filed a Complaint dated 27-01-2021 which was received by this Commission on 29-01-2021 for not getting the information sought by him from the PIO / O/o the Deputy City Planner, Greater Hyderabad Municipal Corporation, L.B Nagar Zone, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated 17-11-2020 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

- I) Please provide me the copy of building application file no. 43876/30/09/2015/EZ, along with enclosed documents as per Rule 15 of A.P. Building Rules, 2012 in compliance of National Building Code – 2005, issued on the SMT. M.RUKMINI AND OTHERS, REP.BY DAGPA HOLDER M/S. SHRI CONSTRUCTIONS.
- II) Please provide me the copy of application form (FORM -1) for " LICENSE OF BUILDER / DEVELOPER / CONSTRUCTION FIRM", as per Rule 29 (a) of A.P. Building Rules, applied by M/S. SHRI CONSTRUCTIONS, represented by SMT V.SRIVANI. (ANNEXURE – IX) along with requirement of documents enclosed as mentioned in Section – 7 of Annexure – IX.
- III) Please provide me the Copy of "UNDERTAKING FOR OBTAINING THE LICENCE", of builder / developer / construction firm as per the A.P. Building Rules, applied by M/S. SHRI CONSTRUCTIONS, represented by SMT V.SRIVANI, along with sanction copy of license.
- IV) Please provide me the "COPY OF LICENSE", (FORM – 2) of Builder / Developer / Construction firm, as per Rule 29 (a) of A.P. Building Rules, issued in favour of M/S. SHRI CONSTRUCTIONS, represented by SMT V.SRIVANI.
- V) Please provide me copy of "BUILDING PERMISSION APPLICATION", with reference to building permit no. 46974/ZC/EZ/Cir-3/2015, dated: 10.12.2015, applied by M/S. SHRI CONSTRUCTIONS, represented by SMT V.SRIVANI. (APPENDIX – I).
- VI) Please provide me the copy of ANNEXURE – X, with reference to building permit no. 46974/ZC/EZ/Cir-3/2015, dated: 10.12.2015. (refer 29 9 (b) of A.P. Building rules, 2012.
- VII) Please provide me the copy of APPENDIX – VIII, -Undertaking with reference to quality of material / workmanship and supervision as per NBC, with reference to building permit no. 46974/ZC/EZ/Cir-3/2015, dated: 10.12.2015.
- VIII) Please Provide me the copy of "APPENDIX – XI" and APPENDIX – XII", "BUILDING COMMENCEMENT NOTICE", dated: 09.01.2016 with reference to building permit no. 46974/ZC/EZ/Cir-3/2015.
- IX) Please provide me the copy of "BUILDING COMPLETION NOTICE", dt:14.06.2017, with reference to building permit no. 46974/ZC/EZ/Cir-3/2015.

The Public Information Officer has not furnished the information to the Complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and case is posted for hearing on 24-09-2021.
