ORDER

Sri M. Ram Reddy, Sangareddy District has filed a Complaint dated 01-02-2021 which was received by this Commission on 04-02-2021 for not getting the information sought by him from the PIO / O/o the Tahsildar, Mandal Revenue Officer, Zaheerabad Mandal, Sangareddy District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **24-11-2020** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

Respected Sir / Madam,
I, **M. RAM REDDY S/O LATE M. BAGA REDDY** aged about 54 years, occ : Legal Practitioner R/o H.No. 8-89, Ranjole Merged Village, Zaheerabad Municipality, Sangareddy District, Telangana State seeking the following records & information under RTI Act 2005.
a) A Copy of Mutation Proceeding issued in the name of M. Shiva Kumar S/o M. Eshwariah in respect of Land bearing Sy.No. 68/91 admeasuring Acre 1-27 Guntas Situated at Ranjole Village, Mandal Zaheerabad, Sangareddy District, Telangana State alongwith the copies of documents basising on which the mutation proceeding was issued.
For the said purpose I am enclosing herewith the Postal Order of Rs. 10/- is under R.T.I. Act 2005 Section 6(1) of the Act Certain Records and I am ready to pay fee if any required.
Therefore I request you to kindly provide me the said information and record within the stipulated period of one month from the date of this application.

The Public Information Officer has not furnished the information to the Complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and case is posted for hearing on 10-08-2021.

The case is called on 10-08-2021. The Complainant is absent. The Public Information Officer/ Sri K.Krupadanam, Naib Tahsildar is present.

The Public Information Officer submitted that the complainant is seeking a copy of the mutation proceeding issued in the name of Sri M. Shiva Kumar, S/o. M. Eshwariah in respect of land bearing survey number 68/A1 admeasuring Acre 1-27guntas situated at Rajole Village, Zaheerabad Mandal. He also submitted that vide letter No. B/50/II/2021 dated 27-01-2021, a reply was given to the complainant stating that the application file, date and year of mutation was not mentioned. He further submitted that at present ILRMS was closed, after re-opening of ILRMS site, mutation copies will be furnished to the complainant. He further submitted after tracing out the mutation proceeding copy, sought information was furnished to the complainant vide letter No. B/50/III/2021 dated 04-08-2021.

Since information is furnished, the complaint is closed.
