ORDER

Sri Mohammed Azhar Ali Khan, KV Ranga Reddy District has filed 2nd appeal dated 11-01-2021 which was received by this Commission on 11-01-2021 for not getting the information sought by him from the PIO / O/o the Tahsildar, Mandal Revenue Officer, Kodair Mandal, Nagarkunool District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Nagarkunool Division, Nagarkunool District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **19-06-2020** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

Sub:- Please furnish the information Under Right To Information Act -2005 Req. Reg..

Sir,

Please furnish the detailed information of Proceeding No : A/504/2014 Dt : 02.09.2014

Issued by Tahsildar, Kodair Mandal along with enclosures.

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated **28-08-2020** before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not furnished the information to the Appellant.

As the appellant did not get the information from the Public Information Officer / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and the case is posted for hearing on 02-09-2021.

The case is called on 02-09-2021. The Appellant is absent. The Public Information Officer/ Sri P. Shivanna Goud, Mandal Revenue Inspector is present. The First Appellate Authority is absent.

The Public Information Officer submitted that the appellant is seeking the information with regard to proceeding No. A/504/2014 dated 02-09-2014. He also submitted that after verification of distribution register in the year 2014, the serial number 504 entered as birth certificate. He further submitted that the connected file was not traceable in their office.
