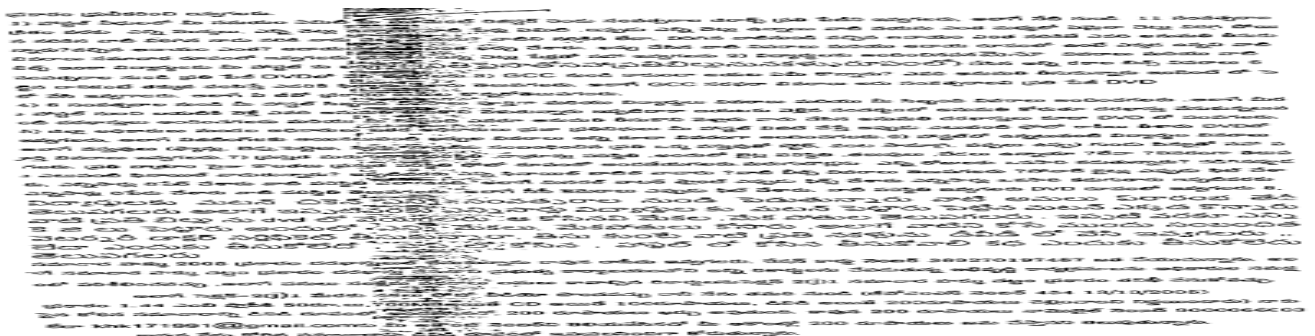

ORDER

Sri Kalangi Hari Krishna, Bhadradri Kothagudem District has filed a Complaint dated 23-03-2020 which was received by this Commission on 16-04-2020 for not getting the information sought by him from the **Public Information Officer-1 /** O/o the Hostel Welfare Officer, Govt. BC College Girls Hostel, Bhadrachalam, Near Subham Function Hall, Bhadradri Kothagudem District. **Public Information Officer-2/** O/o the Hostel Welfare Officer, Govt. BC College Girls Hostel, Manuguru, Samithi Singaram, Ramalayam Back Side, Bhadradri Kothagudem District. **Public Information Officer-3 /** O/o the Hostel Welfare Officer, Govt. BC College Boys Hostel, Manuguru H.No. 8-2-84/7, Sundaraiah Nagar, Bhadradri Kothagudem District. **Public Information Officer-4/**O/o the Hostel Welfare Officer, Govt. The Public Information Officers has not furnished the information to the Complainant

As the Complainant did not receive the required information from the PIOs even after 30 days of filing his applications, he preferred these Complaints before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaints was taken on file and the cases are posted for hearing on 05-08-2021.

The cases are called on 05-08-2021. The Complainant is absent. The Public Information Officers are present.

The Complainant submitted in his affidavit that in all these five cases, he has called for inspection of records and received the desired information from the Public Information Officers.

The Public Information Officers submitted that sought information was furnished to the complainant on 29-12-2020, 11-10-2020, 06-01-2021. They also submitted that the complainant was satisfied with the information.

Since information is furnished, these complaints are closed.
