ORDER

Sri CH.B. Ravi, Nizambad District has filed 2nd appeal dated 22-03-2021 which was received by this Commission on 26-03-2021 for not getting the information sought by him from the PIO / O/o The Mandal Parishad Development Officer, MPP, Sadashivanagar Mandal, Nizamabad District and 1st Appellate Authority / O/o The Mandal Parishad Development Officer, MPP, Sadashivanagar Mandal, Nizamabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **22-01-2021** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated **01-03-2021** before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not furnished the information to the Appellant.

As the appellant did not get the information from the Public Information Officer / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and the case is posted for hearing on 25-08-2021.

The case is called on 25-08-2021. The Appellant is absent. The Public Information Officer/ Smt. V.Padma, Panchayat Secretary is present. The First Appellate Authority is absent.

The Public Information Officer submitted that the appellant was asked to pay an amount towards Xerox charges on 06-02-2021, but there was no response. She also submitted that sought information was furnished to the appellant on 07-04-2021. Since information was furnished, the appeal is closed.
