ORDER

Sri A. Srinivas, Nagarkurnool District has filed 2nd appeal dated 06-04-2021 which was received by this Commission on 08-04-2021 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Nagarkurnool Municipality, Nagarkurnool District and 1st Appellate Authority / O/o the Municipal Commissioner, Nagarkurnool Municipality, Nagarkurnool District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **28-12-2020** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated **18-02-2021** before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not furnished the information to the Appellant.

As the appellant did not get the information from the Public Information Officer / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and the case is posted for hearing on 09-09-2021.

The case is called on 09-09-2021. The Appellant is absent. The Public Information Officer/ Sri G.Yadaiah, Manager is present. The First Appellate Authority is absent.
