ORDER

Sri G. Visweswara Rao, East Godavari District has filed a complaint dated 01-04-2021 which was received by this Commission on 09-04-2021 stating that the Public Information Officer-1 / O/o the Deputy Commissioner, Greater Hyderabad Municipal Corporation, Circle 5, Saroornagar, Hyderabad Public Information Officer-2 / O/o the Deputy Commissioner, Greater Hyderabad Municipal Corporation, Circle 3, Hayathnagar, Hyderabad did not implemented the Commission Order in **9266/SIC-KSR/2019** dated 03-11-2020.

The complainant stated that he was not satisfied with the reply of the Public Information Officer, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him U/s 18(1) of the RTI Act, 2005.

The Complaint was taken on file and case is posted for hearing on 06-09-2021.

The case is called on 06-09-2021. The representative of the complainant is present. The Public Information Officer/ Sri H.Krishnaiah, Deputy Commissioner is present.

The representative of the complainant submitted that he has not received the sought information from the Public Information Officer, Greater Hyderabad Municipal Corporation, Hayathnagar.

The Public Information Officer, Greater Hyderabad Municipal Corporation, Circle-5 submitted that vide letter No.270/F1/H&S/C5/GHMC/2019 dated 24-07-2019, a reply was given to the complainant stating that the death certificate of Smt. Boddipalli Neelaveni was not available in their office.

The Public Information Officer /Greater Hyderabad Municipal Corporation, Circle-3 submitted that after verification of records, sought information will be furnished to the complainant.

The Commission directed the Public Information Officer, Greater Hyderabad Municipal Corporation, Circle-3 to verify the records and furnish the information to the complainant within a week and to report compliance to the Commission.

With the above direction, the complaint is closed.
