ORDER

Sri Maheshwaram Anjaiah, Rangareddy District has filed 2nd appeal dated 07-01-2021 which was received by this Commission on 12-01-2021 for not getting the information sought by him from the PIO / O/o the Gram Panchayat Secretary, Volverthy Village, Valigonda Mandal, Yadadri Bhongiri District and 1st Appellate Authority / O/o The Mandal Parishad Development Officer, MPP, Valigonda Mandal, Yadadri Bhongiri District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **03-10-2020** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

*Subj: Right to information Act 2005
u/s 6(2) furnishing of information
relating to ownership of House
bearing NO 1-37 in Volverthy Village
situated in Volverthy Village
Kindly arrange to furnish the
following information to me*

- 1) Name of the owner on 3-10-2020*
- 2) Payment of House Tax particulars*
- 3) Total Extent in Square yards
mentioned in the Revenue Register*

*I will pay the required cost of
information if exceed above Rs 10/-
I am offering Rs 10/- cost for
copy to the Dist Panchayat
officer Yadadri Bhongiri for
information and necessary action*

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated **04-11-2020** before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not furnished the information to the Appellant.

As the appellant did not get the information from the Public Information Officer / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and the case is posted for hearing on 12-08-2021.

The case is called on 12-08-2021. The Appellant is present. The Public Information Officer/ Sri T. Anand Kumar, Panchayat Secretary is present. The First Appellate Authority/ Sri J.Vinod Reddy, Superintendent is present.

The Appellant submitted that he has received the irrelevant information from the Public Information Officer.

The Public Information Officer submitted that part information was furnished to the appellant on 03-11-2020. He also submitted that a reply was given to the appellant on 05-12-2020 stating that the proceeding copies and related documents of House bearing No.1-137 are not available in their office.

Heard the Public Information Officer and perused the material papers available on record. The Commission observed that the submission of the Public Information Officer that the file is not traceable is not acceptable and directed the Public Information Officer to make thorough search and furnish the sought information to the appellant, within two weeks from the date of receipt of this order and to report compliance.

With the above direction, the appeal is closed.
