## **ORDER**

Ms Y. Surekha, Medak District has filed a Complaint dated 09-04-2021 which was received by this Commission on 12-04-2021 for not getting the information sought by him from the PIO / O/o the Tahsildar, Mandal Revenue Officer, Chegunta Mandal, Medak District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **13-08-2018** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

The Public Information Officer has not furnished the information to the Complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and case is posted for hearing on 24-08-2021.

The case is called on 24-08-2021. The Complainant is absent. The Public Information Officer/ Sri S. Madhusudhan, Naib Tahsildar is present.

The Public Information Officer submitted that vide letter No. B/1748/2018 dated 11-09-2018, information was furnished to the complainant. He further submitted that vide letter No.RTI/19/2019 dated 12-12-2019, sought information was furnished to the complainant.

Since information is furnished, the complaint is closed.
