## **ORDER**

Sri A. Srinivas, Seucnderabad has filed 2<sup>nd</sup> appeal dated 12-04-2021 which was received by this Commission on 12-04-2021 for not getting the information sought by him from the PIO / O/o the Deputy Commissioner, Greater Hyderabad Municipal Corporation, Circle 4, L.B. Nagar, Hyderabad and 1<sup>st</sup> Appellate Authority / O/o the Zonal Commissioner, Greater Hyderabad Municipal Corporation, L.B Nagar Zone, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **16-12-2020** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated **01-03-2021** before the 1<sup>st</sup> Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not furnished the information to the Appellant.

As the appellant did not get the information from the Public Information Officer / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and the case is posted for hearing on 06-09-2021.

The cases are called on 06-09-2021. The Appellant is absent. The Public Information Officer is absent. Sri D. Samson, Assistant City Planner is present on behalf of the Public Information Officer. The First Appellate Authority is absent.

The representative of the Public Information Officer submitted that vide letter No.RTI/147/TPS/Cir-4/GHMC/2021 dated 16-01-2021, available information was furnished to the appellant.

The Commission observed from the perusal of facts on record that information sought in the RTI Application(s) is huge and not specific and advised the appellant to seek specific information in particular matters of larger public interest so that the same could be identified and furnished and also the formatted applications and demanding voluminous information will not be entertained hereafter.

With the above observation, these appeals are closed.
