ORDER

Sri R. Mohan, Hyderabad has filed 2nd appeal dated 16-04-2021 which was received by this Commission on 19-04-2021 for not getting the information sought by him from the PIO / O/o the District BC Welfare Officer, BC Welfare Department, Medchal Malkajgiri District and 1st Appellate Authority / O/o the District BC Welfare Officer, BC Welfare Department, Medchal Malkajgiri District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **02-12-2020** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

1. మెడ్చల్-మల్కాజ్ గిరి జిల్లా వెనుకబడిన తరగతుల సంక్షేమ శాఖ హోస్టల్స్ కు సంబంధించిన 2017 జనవరి నుండి 2020 నవంబర్ వరకు గల PRE-MATRIC & POST MATRIC Hostels కి అందించిన DIET, Office Expenditure, Other Office Expenditure, Electricity, Cosmetics, House Rents కి కేటాయించిన బడ్జెట్ వివరాలు అందించగలరు.
2. మెడ్చల్-మల్కాజ్ గిరి జిల్లా BC Welfare Dept. హోస్టల్స్ కి సంబంధించిన 2017 జనవరి నుండి 2020 ఇప్పటివరకు PRE-MATRIC & POST MATRIC ప్రతి వసతి గృహాంలో చేసిన బిల్లుల TBR నంబర్, బిల్లు ఓచెట్ల మరియు వీటికి సంబంధించిన bchostels.cgg.gov.in లో ఎంట్రీ చేసిన సమాచారం నుండి Form 58, Form 02, Form 04 ల యొక్క Xerox Copy లు అందించగలరు.
3. మెడ్చల్-మల్కాజ్ గిరి జిల్లా BC Welfare Dept. హోస్టల్స్ (PRE-MATRIC & POST MATRIC) కి సంబంధించిన 2017 జనవరి నుండి 2020 నవంబర్ వరకు Cash Register Xerox అందించగలరు.
4. మెడ్చల్-మల్కాజ్ గిరి జిల్లా BC Welfare Dept. హోస్టల్స్ (PRE-MATRIC & POST MATRIC) కి సంబంధించిన ఈ బిల్లులకు సంబంధించి వెండ్రుకు ముట్టినటువంటి రిసీట్స్, ఓచెట్ల మరియు DDO Bank account statement 2017 జనవరి నుండి 2020 నవంబర్ వరకు పూర్తి సమాచారం అందించగలరు.

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated **12-01-2021** before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not furnished the information to the Appellant.

As the appellant did not get the information from the Public Information Officer / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and the case is posted for hearing on 14-09-2021.

The case is called on 14-09-2021. The Appellant is absent. The Public Information Officer is absent. Smt C. Sridevi, Senior Assistant is present on behalf of the Public Information Officer. The First Appellate Authority is absent.

The Appellant submitted that he has received the sought information from the Public Information Officer.
