## **ORDER**

Sri M. Yadagiri, Hyderabad has filed a Complaint dated 19-04-2021 which was received by this Commission on 22-04-2021 for not getting the information sought by him from the PIO / O/o The Deputy Commissioner, Greater Hyderabad Municipal Corporation, Saroornagar, Circle No. 5, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **22-02-2021** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

The Public Information Officer submitted that vide letter No.RTI/219/DC-5/2021 dated 22-03-2021, a reply was given to the complainant stating that to seek specific information, so that same could be identified and furnished.

In view of the above, the complaint is closed.
