ORDER

Sri Mohd Ashraf, Sirpur- Kaghaznagar has filed these Complaints dated 19-07-2020 which was received by this Commission on 28-07-2020 for not getting the information sought by him from the PIO / O/o The Mandal Parishad Development Officer, MPP, Bejjur Mandal, Komaram Bheem District.

The brief facts of the case as per the Complaints and other records received along with it are that the Complainant herein filed an applications dated **22-11-2019, 16-12-2019, 30-10-2019, 30-09-2019, 04-09-2020** before the PIOs under Sec.6(1) of the RTI Act, 2005.

The Public Information Officers has not furnished the information to the Complainant.

As the Complainant did not receive the required information from the PIOs even after 30 days of filing his applications, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and cases are posted for hearing on 15-07-2021.

On overview spread of COVID-19, the case was heard over phone on 15-07-2021. Both the parties are contacted on telephone. The Complainant was heard and the Public Information Officer has not responded to the call.

The Complainant submitted that he has not received the sought information from the Public Information Officer.

When contacted the Public Information Officer, there was no response.

A perusal of facts on record goes to show that the Public Information Officer has not furnished any information to the complainant.

The Commission directed the Public Information Officers to call the complainant for inspection of records to their office and furnish the available information to the complainant, within two weeks from the date of receipt of this order and to report compliance to the Commission.

With the above direction, these complaints are closed.

Issue Show Cause Notice to the Public Information Officer for not responding to the call and for not furnishing the sought information to the complainant within stipulated time.
