## **ORDER**

Sri MD. Qutubuddin, Hyderabad-502 032 has filed 2<sup>nd</sup> appeal dated 29-04-2021 which was received by this Commission on 29-04-2021 for not getting the information sought by him from the PIO / O/o the Tahsildar, Mandal Revenue Officer, Toopran Mandal, Medak District and 1<sup>st</sup> Appellate Authority / O/o the Tahsildar, Mandal Revenue Officer, Toopran Mandal, Medak District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **05-01-2021** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

**Sub:** Request for information under Right to Information Act 2005 of Pahanis, ROR, and Proceedings copies of survey number 505 from 1978 to 1995 and Pahanis.

As cited above I, MD. Qutubuddin, being a citizen of Republic Of India and the rights conferred in the RTI Act 2005 to the citizens, I would like to know the following information from you, under section 6 sub-section (1) of the said act. Under Section 2(j) (ii) of the RTI act, I request you to send the certified copies of the said information with signature and seals of authorized officer.

Name of Village: Toopran

Request for information with certified copies under Right to Information Act 2005 of Pahanis, ROR, and Proceedings copies of survey number 505.

I am affixing court fee stamp of Rs. 10 as application fee.

I would like to receive this information in printed format and through Registered Post at my address. If any further RTI Fees are required, then please let me know that according to the rules on either through my contact number given below or through post, I am ready to pay. I undertake to pay the entire amount through demand draft and please kindly mention the authority on whose name I should take demand draft.

Requesting you, if the information sought pertains another department and/ or another authority then transfer it under section 6(3) of the RTI Act 2005 and send a intimation to me. Please send the information within time specified under section 7(1) of the said act. If you, at any circumstances, reject this RTI application then do send the mandatory information u/s 7(8) (i), 7(8) (ii), 7(8) (iii) of the said act.

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated **20-02-2021** before the 1<sup>st</sup> Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not furnished the information to the Appellant.

As the appellant did not get the information from the Public Information Officer / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and the case is posted for hearing on 21-09-2021.

The case is called on 21-09-2021. The Appellant is absent. The Public Information Officer / Sri S. Nagavardhan, Naib Tahsildar is present. The First Appellate Authority is absent.

The Public Information Officer submitted that the appellant is seeking information relating to pahanies, ROR and proceeding copies with regard to survey number 505 situated at Toopran Village and Mandal, Medak District. He also submitted that vide Endorsement No. A/550/2021 dated 20-09-2021, available information was furnished to the appellant.

The Commission directed the Public Information Officer to furnish the sought information to the appellant through Registered post with acknowledgment due, within two weeks from the date of receipt of this order and to report compliance to the Commission.

With the above direction, the appeal is closed.
