## **ORDER**

Sri Devadas, Sangareddy District has filed 2<sup>nd</sup> appeal dated 22-09-2020 which was received by this Commission on 23-09-2020 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Zaheerabad Municipality, Zaheerabad Mandal, Sangareddy District and 1<sup>st</sup> Appellate Authority / O/o the Municipal Commissioner, Zaheerabad Municipality, Zaheerabad Mandal, Sangareddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **01-06-2020** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

- ① సీహెచ్ఆర్ఎస్ డివిజన్ లోని కలెక్షన్లు విన్న
- ② డివిజన్ కలెక్షన్ల గల కలెక్షన్లు వివిధ డివిజన్లు
- ③ పట్టణ విభాగం గల కలెక్షన్లు కలెక్షన్ల సందర్భంగా
- ④ వీసీఐ సిబిసి కలెక్షన్లు విన్న, బిఆర్ఎస్ కలెక్షన్లు విన్న, వాటిపై

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated **18-07-2020** before the 1<sup>st</sup> Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not furnished the information to the Appellant.

As the appellant did not get the information from the Public Information Officer / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and the case is posted for hearing on 28-07-2021.

The case is called on 28-07-2021. The Appellant is present. The Public Information Officer/ Sri A. Naresh Kumar, Manager is present. The First Appellate Authority is absent.

The Appellant submitted that he has received the part information from the Public Information Officer.

The Public Information Officer submitted that the then Public Information Officer has not furnished the sought information to the appellant within stipulated time. He also submitted that vide letter No.RTI/17/2021 dated 22-07-2021, sought information was furnished to the appellant.

Since information is furnished, the appeal is closed.

**Issue Show Cause Notice to the then Public Information Officer/ Sri G. Prabhakar, Revenue Officer for not furnishing the sought information to the appellant within stipulated time. Action on the Show Cause Notice shall be dealt separately.**
