ORDER

Sri Ch. Prabhakar, Medak District has filed a Complaint dated 29-09-2020 which was received by this Commission on 05-10-2020 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Narsapur Municipality, Narsapur, Medak District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated **30-07-2020** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application annexed.

Sub: Information regarding house bearing no. 2-6 situated at narsapur

I, Ch. Prabhakar S/o Laxmaiah R/o H. No-2-53/1, Jagannathrao Colony, Narsapur Municipality, Medak District, Telangana State here by represent few lines below for furnishing the information & relevant documents U/s 9 of right to information act 2005 as detailed below:

I, request the competent authority to furnish the name of the owner of the house bearing No. 2-6 situated at ward no.11, near hanuman temple, Narsapur, Medak district as per the demand register maintained in your office.

I, further request the kind officer to furnish the certified copies of Demand Bill/Notice pertaining to the house no. 2-6 for the FY 2017-18, 2018-19 & 2019-20 & 2020-21 as per the records maintained in your office

The information can be furnished within 30 days from date of receipt of this application as prescribed under section 6(1) of the RTI Act – 2005. And the information should be furnished Point Wise as stated above and the same shall be sent through Registered Post to under Signed address Only

I submit that, without prejudice to my rights under the RTI Act 2005, to facilitate faster retrieval of information, I would like to state that the information could be available in this office

I further state that, the information sought does not fall within the restrictions contained in section 8 and 9 of the act and to the best of my knowledge it pertains to your office. I also state that, I am a citizen of India and i am eligible to seek information under the Right to Information Act 2005.

And further state that, I am ready to pay the prescribed fee for the certified copies which are to be furnished through information, And request your good self to intimate to the undersigned contact number /address for making payment

A Court Fee of Rs 10/- has been fixed to the application as prescribed under the Act. The information can be sent to the Undersigned address under registered post only as the Act

The Public Information Officer has not furnished the information to the Complainant.

As the Complainant did not receive the required information from the PIO even after 30 days of filing his application, he preferred this Complaint before the Commission u/s 18(1) of the RTI Act, 2005 requesting to arrange to furnish the information sought by him.

The Complaint was taken on file and case is posted for hearing on 28-07-2021.

The case is called on 28-07-2021. The Complainant is present. The Public Information Officer/ Sri V. Madhusudhan, Manager is present.

The Complainant came after hearing and submitted that he has not received any information from the Public Information Officer. He also submitted that the Public Information Officer has not mentioned the name of the owner for H. No.2-6. He further submitted that he has not received the certified copy of the demand bill.

The Public Information Officer submitted that vide letter No.MCN/2021 dated 24-07-2021, available information was furnished to the complainant.

Heard both the parties and perused the material papers available on record. The Commission directed the Public Information Officer to furnish the name of the owner and also the certified copies of demand bill of house bearing No.2-6 situated at ward No.11 to the complainant, within two weeks from the date of receipt of this order and to submit compliance report to the Commission.

With the above direction, the complaint is closed.
