ORDER

Sri Mailaram Kumari Krishnaiah, Medak District has filed 2nd appeal dated 06-10-2020 which was received by this Commission on 09-10-2020 for not getting the information sought by him from the PIO / O/o the Tahsildar, Mandal Revenue Officer, Medak Mandal, Medak District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Medak Division, Medak District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **02-07-2020** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

The Public Information Officer has given a reply to the appellant on 28-07-2020 vide reference No.A/RTI/2729/2020.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated **28-07-2020** before the 1st Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not furnished the information to the Appellant.

As the appellant did not get the information from the Public Information Officer / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and the case is posted for hearing on 08-04-2021.

"The case is called on 08-04-2021. The representative of the Complainant is present. The Public Information Officer is absent.

“The representative of the Complainant submitted that he has filed 6(1) application dated 02-07-2020 seeking information on two items. He also submitted that he has not received any information from the Public Information Officer.

The absence of Public Information Officer caused much displeasure to the Commission and his absence is nothing but dereliction of duty in implementing the provisions of RTI Act. Hence the PIO is warned to attend the future proceedings if any personally before the Commission.”

The case was adjourned to 05-05-2021.

“On overview spread of COVID-19, the case is heard over phone on 05-05-2021. Both the parties are contacted on telephone. The Appellant and the Public Information Officer are heard.

The Appellant submitted that he is seeking the certified copy of D-Form patta certificate from the Public Information Officer. He also submitted that the Public Information Officer has not furnished the sought information.

The Public Information Officer submitted that vide Endorsement No. A/RTI/2729/2020 dated 28-07-2020, a reply was given to the appellant that the sought record was not traceable.

The Commission observed that the submission of the Public Information Officer that the file is not traceable is not acceptable and directed the Public Information Officer to make thorough search and furnish the sought information to the appellant within two weeks.”

The case is adjourned to 03-09-2021.

The case is called on 03-09-2021. The Appellant is present. The Public Information Officer is absent. Sri P. Chandra Shekar, Girdwar is present on behalf of the Public Information Officer. The First Appellate Authority is absent.

The Appellant submitted that he has not received the sought information from the Public Information Officer.

The Public Information Officer submitted that vide letter No. A/2729/2020 dated 28-07-2020, a reply was given to the appellant stating that D-Form patta was not traceable in their office. He also submitted that on verification of 1978 record i.e Distribution Register, the SL.No.7333/78 information pertains to Chepiyal Pochaiyah, S/o. Narsaiah R/o. Seeripalli Village on the subject of ROR.

Heard the Public Information Officer and perused the material papers available on record. The Commission directed the Public Information Officer to make a thorough search and furnish the sought information to the appellant, within two weeks from the date of receipt of this order and to report compliance.

With the above direction, the appeal is closed.
