## **ORDER**

Sri M.D. Hayath Uddin, Siddipet Post & District has filed 2<sup>nd</sup> appeal dated 03-02-2020 which was received by this Commission on 03-01-2020 for not getting the information sought by him from the PIO / The District Revenue Officer, O/o the District Collector, Siddipet District and 1<sup>st</sup> Appellate Authority / The District Revenue Officer, O/o the District Collector, Siddipet District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **02-12-2019** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

**నా మనవి విమనగా నేను వెములపూబ్ గ్రామానికి చెందిన వానిని. మనవి చేయునది విమనగా క్రింద అడిగిన వివరాలను పూర్తి ఆధారాలతో నాకు సమాధానం ఇచ్చే వరకు అప్ డేట్ చేసి ధృవీకరించి ఇవ్వగలరని మనవి.**

- 1. 01.01.2017 నుండి నాకు సమాధానం ఇచ్చే వరకు మీ కార్యాలయ ప్రొసేడింగ్ మరియు ప్రొసేడింగ్ ల నోట్ ఫైల్ కాపీల జిరాక్స్ ప్రతులను అప్ డేట్ ప్రతిపేజీని ధృవీకరించి ఇవ్వగలరు.**
- 2. 01.01.2017 నుండి నాకు సమాధానం ఇచ్చే వరకు మీ కార్యాలయం నుండి జారీ అయిన గెజిట్ మరియు వీటి నోట్ ఫైల్ కాపీల జిరాక్స్ ప్రతులను అప్ డేట్ ప్రతిపేజీని ధృవీకరించి ఇవ్వగలరు.**

**పైన నేను అడిగిన సమాచారాన్ని పూర్తి ఆధారాలతో సహా జిరాక్స్ ప్రతులను నాకు సమాధానం ఇచ్చే వరకు అప్ డేట్ చేసి ఇవ్వగలరని కోరుతున్నాను. జిరాక్స్ ప్రతులకు అయ్యే ఖర్చు (సర్వీస్ చార్జ్)ను చెల్లించడానికి నేను సిద్ధంగా ఉన్నాను.**

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated **02-01-2020** before the 1<sup>st</sup> Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not furnished the information to the Appellant.

As the appellant did not get the information from the Public Information Officer / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and the case is posted for hearing on 18-03-2021.

P.T.O

*“The case is called on 18-03-2021. The Appellant is present. The Public Information Officer is absent. Sri S.A Mateen, Administrative Officer is present on behalf of the Public Information Officer. The First Appellate Authority is absent.*

*The Appellant submitted that he has not received the sought information from the Public Information Officer.*

*The representative of the Public Information Officer submitted that the appellant is seeking information on two points. He also submitted that the information sought by the appellant is voluminous in nature.*

*Heard both the parties and perused the material papers available on record. The Commission observed that the absence of the PIO is not in true spirit of RTI Act and rules framed there under. Hence the PIO is warned to attend the future proceedings if any personally before the Commission.*

*The Commission also warns the Public Information Officer for not attending the hearing and for not furnishing the information to the appellant, within stipulated time and to strictly follow the provisions of the RTI Act, by timely furnishing the information hereafter with reference to Sec. 7(1) of the RTI Act. The respondents are however, cautioned to exercise due care in future to ensure that correct and complete information is furnished timely to the RTI applications as provision of the Act failing which penal proceedings under Section 20 shall be initiated.*

***The Commission therefore instructs the Public Information Officer to Show Cause why action should not be taken under the provisions of the Act for not attending the hearing and negligence. The Commission directs the Public Information Officer to furnish complete information to the appellant, within two weeks. In case, no reply is received within stipulated time period, it shall be presumed that the respondent has nothing more to say and the Commission would take a decision on its merits.”***

**The case was adjourned to 06-09-2021.**

The case is called on 06-09-2021. The Appellant is absent. The Public Information Officer/ Sri S.A Mateen, Administrative Officer is present. The First Appellate Authority is absent.

The Public Information Officer submitted that as per Interim orders of the Commission, a notice was sent to the appellant vide letter No.H7/3143/2019 dated 12-04-2021 and called the appellant for inspection of records on 12-04-2021 at 11.00AM, but there was no response. He also submitted that the same was informed to the Commission vide letter No.H7/1825/2019 dated 17-04-2021.

Heard the Public Information Officer and perused the material papers available on record. The Commission observed that as per directions the Public Information Officer has issued notice to the appellant, but no response from the appellant.

In view of the above, the appeal is closed.
