## **ORDER**

Sri I. Sathya Narayana, Peddapalli District has filed 2<sup>nd</sup> appeal dated 26-10-2020 which was received by this Commission on 28-10-2020 for not getting the information sought by him from the PIO / O/o the Executive Engineer, Irrigation & CAD, Kaleshwaram Project, Construction Division No. 7, Gajwel, Siddipet District and 1<sup>st</sup> Appellate Authority / O/o the Engineer-in-Chief (I), I & CAD Department, Jalasoudha Building, Errum Manzil, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 27-07-2020 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 06-10-2020 before the 1<sup>st</sup> Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not furnished the information to the Appellant.

As the appellant did not get the information from the Public Information Officer / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and the case is posted for hearing on 20-07-2021.

The case is called on 20-07-2021. The Appellant is present. The Public Information Officer/ Sri K. Shafeeq-ur-Rahman, DAO (W) is present. The First Appellate Authority/ Md. Ajmalkhan, Deputy Chief Engineer is present.

The Appellant submitted that he has not received information from the Public Information Officer.

The Public Information Officer submitted that vide letter No.EE/KP/CD7/Gajwel/RTI/PIO/2020-21/441/1 dated 06-09-2020, a reply was given to the appellant. He also submitted that vide letter No.EE/KP/CD7/Gajwel/RTI/2020-21/781 dated 18-12-2020, the appellant was asked to pay an amount of Rs.7510/- towards Xerox charges.

The First Appellate Authority submitted that the appellant is seeking huge and voluminous information. He also submitted that the appellant was called for inspection of records to their office, but there was no response.

Heard both the parties and perused the material papers available on record. The Commission directed the Public Information Officer to call the appellant to their office on any working day and furnish the available information, within two weeks from the date of receipt of this order and to report compliance.

With the above direction, the appeal is closed.
