## ORDER

Sri I. Sathya Narayana, Peddapalli District has filed 2<sup>nd</sup> appeal dated 27-10-2020 which was received by this Commission on 31-10-2020 for not getting the information sought by him from the PIO-1 / O/o the Superintend Engineer, Irrigation & CAD Department, O&M, RTS-B, Ramagundam, Peddapalli District PIO-2/ O/o the Executive Engineer, Irrigation & CAD Department, Irrigation Wing, Peddapalli District and 1<sup>st</sup> Appellate Authority / O/o the District Collector, Peddapalli District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **29-07-2020** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

- 2. ఎంపికలకు వచ్చిన వారి పేర్లు, వయస్సు, ఉన్న ప్రభుత్వ ఉద్యోగాల వివరాలు.

- 3. ఎంపికలకు చేరని వారికి కారణం ఏమిటో తెలియజేసి వారి పేర్లు, వయస్సు, ఉద్యోగాల వివరాలు, వీరూనింగ్ వివరాలు, ఆర్డర్లు తెలియజేసి వివరాలు, మిగిలిన వివరాలను అందించండి.

- 4. సింగిల్ గేట్ మరియు డబ్బల్ గేట్లకు సంబంధించి, వీటి పనుల ప్రయోజనం, పనులు అనుసరించే క్రమం, కెఆర్ కాల గ్రామీణులకు ఉచితంగా ఉన్న వివరాలు, ప్రభుత్వ ఉద్యోగాలకు సంబంధించి వచ్చిన వారి పేర్లు, వయస్సు, ఉద్యోగాల వివరాలు, ఆర్డర్లు తెలియజేసి వివరాలు.

చరణార్థం రుసుం రూ.10/- కేవలం రూ.పంత్ చెల్లించాల్సింది. రుసుం ఎప్పటికీ.

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated **10-10-2020** before the 1<sup>st</sup> Appellate Authority u/s 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority has not furnished the information to the Appellant.

As the appellant did not get the information from the Public Information Officer / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission u/s 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

The Appeal was taken on file and the case is posted for hearing on 20-07-2021.

The case is called on 20-07-2021. The Appellant is present. The Public Information Officer - 1/O/o. The Superintending Engineer, I&CAD, O&M, RTS-B is absent. The Public Information Officer-2/ Sri R.Ilaiah, Technical Officer O/o. Executive Engineer, I&CAD Department, Peddapalli District is present. The First Appellate Authority is absent.

The Appellant submitted that he has received the information from the Irrigation department. He also submitted that he has not received any information from O/o. The District Collector, Peddapalli District.

The Public Information Officer-2 submitted that vide letter No.EE/IB/PDPL/DB/APIO/26/RTI/1set dated 05-09-2020, sought information was furnished to the appellant.

Heard both the parties and perused the material papers available on record. The Commission directed the Public Information Officer/ O/o. The District Collector, Peddapalli District to furnish the sought information to the appellant, within two weeks from the date of receipt of this order and to report compliance to the Commission.

With the above direction, the appeal is closed.
