## **ORDER**

Sri LVG Naidu has filed 2<sup>nd</sup> appeal dated 20-11-2020 which was received by this Commission on 25-11-2020 for not getting the information sought by him from the PIO/ O/o. the Special Deputy Collector, Urban Land Ceiling Wing, Collectorate Complex, Kongara Kalan, Ibrahimpatnam, Ranga Reddy Dist and 1<sup>st</sup> Appellate Authority / O/o. the Special Deputy Collector, Urban Land Ceiling Wing, Collectorate Complex, Kongara Kalan, Ibrahimpatnam, Ranga Reddy Dist.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 03-09-2020 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

1. Status / copy of proceeding of application of Sri A.V. Narayana Dt.: 30.03.2005 (F1/445/46/SA/05) Plot No.: B part, Plot No.: 53 of Survey No.: 78, Patrikanagar, Madhapur, Hyderabad.
2. Status / copy of proceedings of application of Sri M N Vijay Kumar (F1/747/7329/2005) & CC No.: F1/405/05) of C part of Plot No.: 53 of Survey No.: 78, Patrikanagar, Madhapur, Hyderabad.

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1<sup>st</sup> appeal dated 20-10-2020 before the 1<sup>st</sup> Appellate Authority U/s. 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1<sup>st</sup> Appellate Authority failed to hear the case and pass appropriate orders on the 1<sup>st</sup> appeal filed before him.

As the appellant did not get the information from the Public Information Officer / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission U/s. 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

Basing on the material papers available on record, the appeal was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 27-01-2023.

The case is called on 27-01-2023. The Appellant is absent. Sri S.Gopi, Naib Tahsildar is present on behalf of the Public Information Officer. The First Appellate Authority is absent.
