ORDER

Smt. Mani Narayan has filed 2nd appeal dated 13-07-2022 which was received by this Commission on 19-07-2022 for not getting the information sought by him from the PIO / O/o. the Dist. Collector, Kongara Kalan, Ibrahimpatnam, Ranga Reddy Dist-501510 and 1st Appellate Authority / O/o. the Dist. Collector, Kongara Kalan, Ibrahimpatnam, Ranga Reddy Dist-501510.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated 18-02-2022 before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated 31-03-2022 before the 1st Appellate Authority U/s. 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get the information from the Public Information Officer / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission U/s. 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

Basing on the material papers available on record, the appeal was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 09-01-2023.

The case is called on 09-01-2023. The Appellant is absent. The Public Information Officer/ Sri S.Suraj Kumar, Revenue Divisional Officer, Kandukur Division is present. The First Appellate Authority is absent.

The Public Information Officer submitted that the sought information was furnished to the appellant vide Memo No.A5/RTI/25238-27496/2022 dated 19-11-2022, which was despatched on 08-12-2022.

The Commission has perused the above said information dated 19-11-2022 furnished by the Public Information Officer to the appellant.

Since information was furnished, the appeal is closed.
