ORDER

Sri J. Venkata Swamy has filed 2nd appeal dated 22-08-2022 which was received by this Commission on 24-08-2022 for not getting the information sought by him from the PIO-1 / O/o. the Tahsildar, Undavelly Mandal, Jogulamba Gadwal Dist, PIO-2/ O/o. the Dist. R&B Officer, Jogulamba Gadwal Dist and Public Information Officer-3/ O/o. the Dist. Panchayat Officer, Jogulamba Gadwal Dist. 1st Appellate Authority / O/o. the Revenue Divisional Officer, Gadwal Division, Jogulamba Gadwal Dist.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated **16-04-2022** before the PIO under Sec.6(1) of the RTI Act, 2005, requesting to furnish the information on the following points mentioned in his application:

- 1.సర్వ.నెం.371లోని ఏ.15.10 గు.ల ప్రభుత్వ భూమికి సంబంధించి లాపుని పట్టా పొందిన 9 మంది లబ్ధిదారుల పేర్లు, వివరాలు మరియు ఒక్కొక్కరికి కేటాయించిన విస్తీర్ణం.
2. సర్వ.నెం.371లో R&B రోడ్డు కొరకు సేకరించిన భూవిస్తీర్ణం మరియు సర్వ.నెం.371లో వెయబడ్డ రోడ్డు యొక్క పొడవు మరియు వెడల్పు యొక్క కొలతలు.
3. సర్వ.నెం.371లో R&B రోడ్డు తరువాత తూర్పువైపు అనగా R&B రోడ్డు మరియు సర్వ.నెం. 372 భూమి మధ్య ఉన్న భూమి విస్తీర్ణం.
- 4.లబ్ధిదారులైన 9 మందికి ఇచ్చిన లాపుని పట్టాలో ఒక్కొక్కరి నుంచి R&B రోడ్డు కోసం సేకరించిన భూమి విస్తీర్ణం. మరియు రోడ్డుకు సేకరించిన తరువాత వారిలో ఒక్కొక్కరికి మిగిలిన భూమిలో R&B రోడ్డుకు పడమటివైపు అలాగే రోడ్డుకు తూర్పువైపు ఎంత విస్తీర్ణంలో లాపుని పట్టా కలిగి ఉన్నారు.
5. సర్వ.నెం.371 & 372 మధ్యలో ఉన్న డింగు విస్తీర్ణం మరియు పొడవు, వెడల్పుల యొక్క కొలతలు.

The Public Information Officer has not furnished the information to the appellant.

Since the appellant did not receive the information from the Public Information Officer, he filed 1st appeal dated **21-06-2022** before the 1st Appellate Authority U/s. 19(1) of the RTI Act, 2005 requesting him to furnish the information sought by him.

The 1st Appellate Authority failed to hear the case and pass appropriate orders on the 1st appeal filed before him.

As the appellant did not get the information from the Public Information Officer / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission U/s. 19(3) of the RTI Act, 2005 requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him.

Basing on the material papers available on record, the appeal was taken on file and notices were sent to the parties concerned directing them to appear before this Commission for hearing on 03-01-2023.

The case is called on 03-01-2023. The Appellant is present. The Public Information Officer-1/ Ms.S.Jayanthi, Naib Tahsildar O/o. the Tahsildar, Undavelly Mandal, Jogulamba Gadwal Dist-509153 is present. The Public Information Officer-2/ Ms.Pragathi, Executive Engineer(R&B) O/o. the Dist. R&B Officer, Jogulamba Gadwal Dist is present. Sri PVS Ravindar Kumar, Senior Assistant O/o. the Dist. Panchayat Officer, Jogulamba Gadwal Dist is present on behalf of the Public Information Officer-3. The First Appellate Authority is absent.

The Appellant submitted that he has received the information but his grievance is not resolved.

The Public Information Officer-1 submitted that vide Letter No. B/RTI/2022 dated 20-05-2022, information was furnished to the appellant. She further submitted that as per the oral direction of the Commission on the earlier occasion, the appellant was shown an access into his land.

The Public Information Officer-2 submitted that vide letter No.EE/R&B/RTI-2005/Supdt/2022-23 dated 17-10-2022, a reply was furnished to the appellant.

Since the information was furnished by the Public Information Officer-1, the appeal is closed. The Appellant is at liberty to approach the appropriate Forum for redressal of his grievance, if so chooses.
